### **HISTORY/BACKGROUND:**

It is necessary to revise the construction application once again now that we have the actual values stemming from the bid opening and contract award with Morel Construction. The original BG-1 construction application was approved on October 5, 2020. It was revised April 5, 2021 to reflect language changes as required by the Kentucky Department of Education. The construction estimates were not revised in March.

The current bidding climate is in upheaval due to the availability of materials and equipment, shortage of labor, and the overall price of both goods and services. We experienced all of this with the bidding process for Scott, Woodland, and Taylor Mill. The overall increase in construction cost over the 2020 estimate is \$11,318,995.00 or 27% higher than originally approved.
