Change Order Description And Justification

Proposal 43R - At three locations, it was necessary to have new heat pump covers fabricated to provide for the transition between the new and existing. ADD \$2,483.

Proposal 45R - Adding an additional door with a panic device so the District can adjust the phasing to occupy the second floor instead of the third floor, versus the original plan. This will provide for less moving of the District and student disruptions. ADD \$2,278.

Proposal 46R - Add tamper resistant locks on the operable window units in the student restrooms to prevent students from opening the restroom windows without permanently fixing the window sashes shut. This was requested by the District for security measures. ADD \$613

Proposal 47 - Additional floor patching around the new heat pump in Room A14 where there was a large gap between new and existing which looked unsightly and was in need of repair. ADD \$1,223.

Proposal 50 - Additional data drops in Room A14 per walkthrough with District staff for more functionality. ADD \$2,897.

Cost Benefit To Owner

Proposal 43R - Lobby area to Ralph Rush will be completely finished in appearance.

Proposal 45R - Fewer disruptions to the academics.

Proposal 46R - Existing windows in the school restrooms will be fixed shut but not permanently - school staff will be able to open them if needed.

Proposal 47 - Flooring is repaired at the new heat pump.

Proposal 50 - Adding these data drops while the contractor is mobilized on site is the most cost-effective time to do so.
