# **School Calendar Requirements**

- c. 4 Holidays (Labor Day-9/5, Thanksgiving Day-11/24,MLK Day-1/16, & President's Day-Feb. 20.)
- d. 4 PD Days
- e. 3 Professional Learning / Planning Days
- f. 1 Opening Day
- g. 1 Closing Day
- h. 8 Built-in make-up days as required by KDE.



#### **Dates to Consider for Breaks**

Fall Break: 1st Full Week of October: Oct. 3-7

Christmas Break: Last two weeks of December:

December 19 - December 30

Spring Break: April 10-14

This is when KEA has set their annual meeting dates.



#### **Election Dates and FDEA Dates**

EIS Schools will not be used for polling purposes, so we can be in session during the November Election and May Primary.

**2022:** November Election Day is November 8th. (First Tuesday, after the first Monday in November)

\*In the past FDEA Day was scheduled the Monday before Election Day, however it has not been scheduled at this time within our district.

**2023**: Primary Election (first Tuesday after the third Monday in May) is Tuesday, May 16th

Schools are required to be closed during Presidential Elections.



### **Calendar Option 1**

Very similar to this year's calendar.

3 PD Days before school and 1 in November on Election Day.

3 Professional Learning / Planning Days (Aug. 8, Oct. 10, and Jan. 2)

1st Day of School will be Aug. 10th Last Day of School will be May 24th

1st Day of Preschool will be Aug. 18th Last Day of Preschool will be May 16th

FDEA Dismissal Day - Nov. 7th



### **Calendar Option 2**

ALL 4 PD Days will take place before school starts.

3 Professional Learning / Planning Days (Oct. 10, Jan. 2, and April 17)

1st Day of School will be Aug. 10th - same as option 1 Last Day of School will be May 25th - 1 day later


1st Day of Preschool will be Aug. 18th - same as option 1 Last Day of Preschool will be May 17th - 1 day later

FDEA Dismissal Day can take place on Nov. 21st or Nov. 22nd School will be dismissed Mon- Friday during Thanksgiving Week.

# **Handle With Care Program Update**

The "Handle With Care" Model:

If a law enforcement officer encounters a child during a call, that child's name and three words, **HANDLE WITH CARE**, are forwarded to the school/child care agency before the school bell rings the next day.


This allows for school administrators, counselors, and teachers to be on standby in case a student needs support throughout the school day.

If a child needs more intervention, we will ask a school counselor or the new EIS Social Worker, Miranda Burnett to provide additional support to the student.
