A legal advertisement was placed in the Kentucky Enquirer on March 7, 2017 to accept sealed bids for "Playground Mulch". Sealed bids were opened and read on March 28, 2017, at 2:00 p.m. The Board awarded the bid to Central Lawn Care on May 1, 2017. This was a one year bid award with two optional annual renewals. This is the second of two optional annual renewals available under the original bid.


