A public notice was placed on the Kenton County Schools website on June 15, 2017 to accept sealed bids for "Waste Removal and Recycling". Sealed bids were opened and read on July 6, 2017, at 2:00 p.m. The Board awarded the bid to Best Way Disposal on August 7, 2017. This was a one year bid award with two optional annual renewals. This is the second of two optional annual renewals available under the original bid.
