01.1 Legal Status of the Board

HISTORY/BACKGROUND:

Me and My School (MMS) Kindergarten Transition program focuses on engaging at-risk children in quality early learning experiences that promote and benefit kindergarten readiness as well as their families to participate in school readiness activities and events. Identified schools to participate include Piner, River Ridge, Kenton, Summit View and White's Tower. The specific outcomes projected are having 90% of parents identify the MMS Kindergarten Transition program as having helped prepare their child for Kindergarten AND students attending the MMS show increased readiness rates. These outcomes align with School Readiness Goal 4: Increasing the number of children, particularly those at risk, participating in high quality early care and education programs and Governor's Office of Early Childhood (GOEC) strategy 2. Engaging families as their child's first and most important teachers and GOEC strategy 4. Enhancing the ability to measure the impact of the work by improved data and collection and integration.


This agreement assures that Ellen Zimmer or her appointed representative will:

- a. attend scheduled *Me and My School* meetings and training during 2019;
- b. be familiar with and responsible for assuring the **Data Sharing and Use Agreement** is fully implemented and adhered to;
- c. submit an implementation plan using the templates created for the *Me and My School* program;
- d. develop a partnership with the school district's early childhood community;
- e. submit documents, project results and other data according to the 2018-19 Schedule of Events and Reports;
- f. Identify the partnerships with United Way of Greater Cincinnati by printing the logos and taglines on all materials purchased with *Me and My School* funds and identifying the partnerships in presentations.

United Way of Greater Cincinnati will:

- a. provide **\$2,300.00** grant for one (1) year of activities;
- b. coordinate *Me and My School* program meetings during 2019;
- c. provide materials and information required for successful partnership with UWGC, including the **Data Sharing and Use Agreement**, Schedule of Events and Reports, and standardized reporting forms;
- d. be available to attend district *Me and My School* meetings and related events if requested;
