#### **HISTORY/BACKGROUND:**

The goal of the NSFY Grant is to grow the partnership between Boone County Schools (BCS) and the Kenton County School District (KCSD) including post-secondary partners and industry partners to continue the short term and long-term goals in establish the Ignite Institute as an all-day career academy. BCS and KCSD have established a collaborative partnership in creating the Ignite Institute. The NSFY Grant will allow both districts to learn about all day career academies in Kentucky and across the U.S. Ignite Institute is a choice school and the NSFY Grant will provide funds for marketing for scholars to learn about what it offers. In addition, the NSFY Grant will provide funds to learn about Career and Technical Education through trainings and conferences. Some legal fees will also be covered under the grant. The NSFY Grant will be up to \$110,000. The end outcome will be educators better prepared to teach our scholars to become Transition Ready.

- 5. Ensure New Skills for Youth planning grant funds are used in strict compliance with the terms of the grant.

This is very hard work, but exciting work at the same time. The KDE is committed to assisting you with all aspects throughout the planning period and beyond. We are determined to change the traditional high school experience for students.
