I, Martin A. Pollio, am an authorized representative of Jefferson County School District Finance Corporation ("Owner"), which owns properties and buildings ("Property") located:

My signature below certifies that I have the legal authority to give this permission.

ShotSpotter, Inc. ("ShotSpotter") has found that the Property are good locations to place a sensor to assist local public safety. This sensor is part of an alarm system which will contribute to neighborhood safety. The electronic sensor is in small tan box (approximately 9"x9"x4" weighing 3lbs) to be mounted discreetly in an "out of sight" fashion on the rooftop and will be connected to a network via a cellular data modem. The equipment uses less than 3 total watts of power, roughly half the equivalent of a night light.

Owner grants ShotSpotter, and its employees and contractors, permission to place a removable sensor on the Property, and to enter on to that Property at reasonable times and with reasonable notice to install and maintain the sensor, and for the use of electricity to power the sensor, at no cost to ShotSpotter or the local public safety agency.

If Owner wants to revoke this permission, Owner will give 60 days' notice to ShotSpotter by email to support@shotspotter.com. As long as the sensor is on the property, we will take reasonable care to protect it and to maintain electrical service and will advise ShotSpotter if we know it becomes damaged or unpowered.

ShotSpotter and Owner will keep private the location of the sensor, understanding that this is law enforcement sensitive information.

If a third person makes a claim against Owner for personal injury or property damage, ShotSpotter will pay for documented expenses and legal liability incurred by Owner in connection with such claims, but only to the extent the claimed injury or damage is caused by the negligence of ShotSpotter employees or contractors in installing or maintaining the sensor, and as long as Owner gives ShotSpotter reasonable notice and allows ShotSpotter to control the selection of defense counsel, defense, and settlement of such claims. However, ShotSpotter's obligation to pay for such expenses and liability will be limited to, and will not exceed, the amount of ShotSpotter's available liability insurance coverage for such expenses and liability.
