Definition Change

From the Commissioner's Message: January 18

"Up to Date" vaccination status means that the individual has received all vaccines and boosters they are eligible for, determined by their age, health status, etc.

- Adults <u>></u>18 years old who are fully vaccinated do not need to quarantine following an exposure to COVID-19.
- Children 5-17 years old who are fully vaccinated do not need to quarantine following an exposure to COVID-19. Children 12-17 years of age who received their second Pfizer vaccine five months ago still are encouraged to receive their booster.

- Mask mandate inside buildings and on buses
- **Masks available** for employees and students who need them--delivered KN-95 masks to school for employees and these continue to be available
- Voluntary testing available weekly in schools/worksites
- Drive-through testing available in over 50 sites after school
- Vaccine or testing mandate for employees

Mitigation Measures

- **Test to Stay** program for those exposed to allow them to test and then return with a negative test
- **Test to Play** program for extracurricular activity participants
