### **HISTORY/BACKGROUND:**

This is the second (2<sup>nd</sup>) change order for the Ryland Heights Addition and Renovation Project associated with Century Construction. The original contract was \$4,368,195.00. This change order for an additional \$5,048.19 with a previous change order of \$18,451.58 makes the new contract sum \$4,391,694.77.

Item No 1: Increase elevator equipment room door size from 3' 0" to 3' 6" per elevator manufacturer shop drawing submittal. ADD: \$ 344.56

Item No 2: Add trench drain at new sidewalk and exterior door from Cafeteria.

ADD: \$ 4,703.63

TOTAL ADD: <u>\$ 5,048.19</u>

#### Item No. 02-02 (PCO 16)

Add trench drain at new sidewalk and exterior door from Cafeteria

Cost Benefit to Owner: Due to inability to sheet drain away from the new door given the existing grades the trench drain is provided to prevent stormwater infiltration into the cafeteria thru the door. ADD \$4,703.63
