#### **APPLICABLE BOARD POLICY:**

01.1 Legal Status of the Board

#### HISTORY/BACKGROUND:

There are currently over 35 languages spoken throughout KCSD. To ensure meaningful communication and to comply with Title III federal guidelines, interpreters are needed for families with limited English proficiency as requested. These interpreters are utilized with parents/guardians and not with students. The revised addendum changes the terms of billing, to be paid 60 days from the time of invoice instead of 30 days, at our request. Affordable Language Services has also changed their rates; new rates are reflected in the addendum.

#### FISCAL/BUDGETARY IMPACT:

Schools/District will request interpreting/translating services with a purchase order and will be billed individually, to be paid 60 days from the invoice date (update to the terms in the addendum, at our request).

#### **RECOMMENDATION:**

**Approval** of the revised addendum to the service agreement with Affordable Language Services to provide interpreting and translating services for all schools and the district through May 1, 2023.


