**KY Superintendent Webcast, January 11:** Executive Director Amy Razor attended the regularly scheduled monthly webcast led by the Education Commissioner, Dr. Jason Glass, and state leaders to keep informed on current topics. The group largely discussed the legislative session and the items to pay particularly close attention to.

**KASS Legislative Drive In Day, January 12:** Executive Director Amy Razor, along with educational leaders around the state gathered in Frankfort, KY for the opportunity to speak with legislators on topics important to the education community. The day was filled with rich and insightful conversations. We are grateful for KASA and the important role they play to make this event possible.

**KASS Legislative Committee Meeting, January 14:** Executive Director of KASS, Dr. Jim Flynn, has established recurring meetings for superintendents to discuss current bills that affect education during the legislative session.

**KDE, Youth Mask Distribution, January 18:** Executive Director Amy Razor attended a virtual meeting where KDE shared that our state has received pallets of youth face masks that they wish to distribute across the state to school districts. **Superintendent Purpose Retreat, January 19-21:** Dr. Robb Smith, Executive Director Amy Razor and Chief Academic Officer Melody Stacy led superintendents in a recalibration retreat. The feedback was incredible and the topics of well-being and purpose were timely.

**KDE Monthly Education Cooperative Director Meeting, January 24:** Executive Director Amy Razor, along with other KDE Leaders and Education Cooperative Directors participated in the monthly virtual meeting



**Apptegy Zoom Meeting, January 25:** NKCES will be working with Apptegy to design a platform, website and, in turn, exciting services for our region in the next two months. We are ready to take our digital footprint to the next level!

**KASS Legislative Committee Meeting, January 28:** Executive Director Razor participated in a statewide call with Dr. Flynn. He shared updates and items of importance on this call as it relates to the current legislative session.

Deeper Learning Grant, January 31: Executive Director Razor worked along side KAEC Cooperative Directors for an extensive period of time to take The Deeper Learning Grant from an idea to reality. The cooperatives describe Deeper Learning as engaging students meaningfully in education through the use of multiple learning methods. Deeper Learning strategies include, but are not limited to, personalized learning, higher-order thinking, blended learning, project-based learning, work-based experiences, connected learning, experiential learning, and competency-based education. The Deeper Learning initiative will invest millions into school districts for professional learning, ongoing support, and additional time for educators to select and tailor strategies for their schools. Every school district in the state of Kentucky will have the opportunity to participate in this 3 year opportunity.

Mrs. Becky Nixon attended the Kentucky Council of Administrators of Special Education (KYCASE) Executive Board Monthly Planning Meeting. The executive board is working on final plans for the New DoSE Institute on January 31, the March DoSE Institute, Summer New DoSE Institute on July 17, and Summer DoSE Institute on July 18-19.

Dr. Laura Clarke participated in a Council for Exceptional Children - Complex and Chronic Conditions division board meeting on January 17.



Dr. Merissa Waddey serves as Co-Chair of the Local Arrangement Committee for CEC at the Convention in Orlando and collaborated to promote the CEC Convention coming to Louisville in March 2023.

Dr. Laura Clarke and Dr. Merissa Waddey continued to provide ongoing support to the Regional Schools Program with coaching, observations, adapted materials, and visual behavior support.

#### **CRRSA Update:**

The CRRSA team partnered with 14 districts and supported 238 educators and students in Northern Kentucky this month. Some of the supports included new teacher coaching, behavior coaching, Inquiry in the KAS for Social Studies, writing initiatives, and supporting educators in taking a trauma informed approach. The team is honored to present their first regional training on KyMTSS in February, which will be followed by a Local Curriculum Design and High Quality Instructional Resources regional training in March.

As a response to the request for a collective space to highlight best practices in our region, *teachNKY* collaborative is a publication of the NKCES CRRSA team and will be published Feb 1st. Each month's edition will highlight a new topic and feature ideas along with NKY educators leading the way.

#### **Professional Learning (PL) Update:**

**January Professional Learning:** NKCES supported a total of 147 professional learning opportunities focused on academics, culture and climate, leadership, and special education during the months of January serving 1,423 educators.

**NKCES Professional Learning Online Platform** has proudly served more than 35,809 educators since the inception of its first online learning Google site, with 706 educators completing modules in January 2022. NKCES online learning options have grown from one site with six trainings that debuted in the spring of 2020 to six sites with 125+ free online trainings as well as a variety of free online trainings and curated resources and support for educators, parents, caregivers, and substitute teachers.

The next Regional Alternative Program Meeting will be held on April 20th, in person, hosted by Rise Academy in Boone County.

One of our community partners, The Bridge Church, raised and donated \$12,000 to RSP to go towards a dream of a playground for RSP.

We are working on our draft 22-23 calendar.

# **English Learners (EL) Program Update:**

The EL Consultants, Heather Ralphes and Daniele Novak, have been administering ACCESS testing to our EL students in our EL Program districts. The ACCESS testing window ends on February 18th.

## **NK Institute for Arts Education (NKIAE):**

On January 8th, Mr. Joe Bertucci led teachers from our arts integration program in a 3-hour planning workshop focused on implementing units that connect the arts with social studies and SEL.



On January 20th, Mr. Bertucci collaborated with Heather Hicks from NKAGE to lead January's NKCES Visual & Performing Arts PLN meeting focused on *Gifted and Talented in the Arts*.

Mr. Bertucci is collaborating with members of the NKIAE Steering Committee and project partners, including the Harris Media Company and Visionaries + Voices, to plan implementation of the new *Assistance for Arts Education* Grant. He is also collaborating with Alissa Paasch from The Carnegie to prepare a presentation for the Kennedy Center's Partners in Education virtual conference, to be held February 8-9.

Mr. Bertucci observed two lessons and provided feedback to the Arts Integration Team at Lindeman Elementary.
