THIS RESOLTION ALSO ESTABLISHES PROCUREMENT POLICY FOR ANY KOHS APPROVED PROJECT FOR THE FY-2019 APPLICATION CYCLE.

WHEREAS, the Kenton County School District desires to make an application for United States Department of Homeland Security funds for a project to be administered by Kentucky Office of Homeland Security:

For any equipment and/or services under \$20,000 three (3) quotes will be obtained. For any equipment and/or services that exceeds \$20,000 the provisions of KRS 45A will apply.
