Consider/Approve Create the position of "Northern Kentucky Youth Development Center (NKYDC) Lead Teacher" and establish a corresponding job description with a stipend on the supplemental salary schedule.

## HISTORY/BACKGROUND:

In accordance with the Memorandum of Agreement between the Kentucky Educational Collaborative for State Agency Children (KECSAC) and the Kenton County School District (KCSD), the District provides a school administrator to oversee the Northern Kentucky Youth Development Center (NKYDC) through the position of Director of District Wide Services. The Director does have additional responsibilities in the District that prevents 100% on-site attendance at NKYDC. To address times when the Director is off-site or participating in additional responsibilities, creation of a NKYDC Lead teacher position will allow for standard and routine elements of managing NKYDC to occur as needed while providing leadership and guidance to the teachers and support staff of NKYDC for all 210 days of operation.

#### **FISCAL/BUDGETARY IMPACT:**

\$3,110 paid as an annual stipend to the certified teacher holding the position of NKYDC Lead Teacher

#### **RECOMMENDATION:**

It is recommended the position of NKYDC Lead Teacher be created and the corresponding job description and stipend on the supplemental salary schedule be approved.

## PERFORMANCE RESPONSIBILITIES:

- 1. Develop teacher/staff schedules, student schedules, school schedules and staff meeting schedules
- 2. Collaborate with Department of Juvenile Justice (DJJ) including participation at DJJ staff meetings, coordinating DJJ and educational records, assisting in DJJ, Kentucky Educational Cooperative for State Agency Children (KECSAC) and Title 1 monitoring
- 3. Monitor instruction and conduct walk-throughs
- 4. Oversee attendance, enrollment and withdrawal of students; TABE testing; Treatment team; includes attending intake meetings and verifying accuracy of intake information, attending all transition meetings and developing Program Transition Plans (PLP).
- 5. Research and maintain educational records (transcripts, credits etc.); Monitor GED requirements; complete progress reports and report cards, award high school credits, monitor seat hour requirements and complete credit checklist.
- 6. Serve as Building Assessment Coordinator (BAC) and monitor student assessment procedures
- 7. Represent NKYDC at all requested DJJ, KECSAC and Kenton County School District meetings
- 8. Perform other duties as assigned by the supervisor
