HISTORY/BACKGROUND:

The KCSD Staff Interpreter position for the 2019-2020 school year has not been filled as of this date. In the past, we have contracted with the Northern Kentucky Services for the Deaf to provide services for our teacher when the position has periodically gone unfilled. We would like to secure their services for the 2019-2020 school year, with the opportunity to cancel the contract in the event we fill the position. The contract has been reviewed by our board attorney.

FISCAL/BUDGETARY IMPACT:

Maximum cost \$70,000.00 – Special Education General Fund
