My name is Chynna Reyes. I am a parent of a 5th grader going into middle school next year. I have grave concerns regarding the Nelson County District Facilities Plan.

Firstly, the Nelson County community was not involved at all with this plan. Once we were made aware of this, many community members have voiced their concerns to little or no avail during multiple school board meetings. There's many social media groups that were created specifically because the community as a whole is against this merger.

I've found some reputable sources below that give the negatives and positives of a potential merger between middle and high schools. After reading these, I still feel the same.

The pros DO NOT outweigh the cons. I've cited multiple resources below to show you that this has already been tried multiple times with very little to show for it besides high cost on the taxpayers. These studies show that there's more potential for negative educational effects on the students; within these studies, it shows little to no positive educational effects on the students.

There hasn't been enough studies on the effects school consolidation has on students when it comes to peer pressure, early introduction to sex and drugs, and bullying from older students.

However, I do have a BA in psychology from the University of Kentucky that has provided me with immense knowledge on possible psychological effects this merger could have on my kid and the community's children.

My family moved to Bardstown 6 years ago because we heard how great the school system was here; I wanted my kid to have the best quality education while still being socialized in a public school that valued education. It was great until Wes Bradley was able to start implementing his horrible ideas onto the Nelson County School District.

Now, I've seen more in school fights, exposure to sex/drugs, and extreme bullying than ever before. I don't want to see Nelson County Schools turn into an inner city school. Bardstown is becoming bigger and bigger.

The growth has potential positives when it comes to profits; however, we must address the potential negatives that would directly affect our children such as more drugs, sex, and violence. If the merger were to be approved, it is inevitable that these factors would just intensify.

However, on social media, I've seen a video of a teenage girl that was ambushed by another teenage girl. Her father let us know that she contacted him and that's how he found out that she was involved in a fight. He also let us know that when his daughter tried to join a morning assembly meeting, she was told that it would be too traumatizing for her to attend.

I'd really appreciate a response on these issues and how Nelson County District plans to change their horrendous responses to these issues.

I'm sure the Kentucky Board of Education has seen a huge decrease in enrollment recently. Would you like this trend to continue? I will surely pull my son out of public school if the merger is approved and either homeschool or send to private school.

However, I do care about my community and know that isn't a realistic option for every family. Kids will be left behind because not every child has a good support system like my son does. Please consider the bigger picture here.
