**Memorandum of Agreement Terms and Conditions**  
Revised December 2019

This Memorandum of Agreement (MOA) is entered into, by and between the Commonwealth of Kentucky, Kentucky Department of Education ("the Commonwealth") and Jefferson County ("the Contractor") to establish an agreement for a Community Engagement Coordinator position. The initial MOA is effective from March 1, 2022 through June 30, 2022.

**Scope of Services:**

This person will provide guidance and resources to educators in Kentucky around family engagement. The coordinator will serve as a connector to bring different groups like community stakeholders, community groups, families, students and educators to the table in order to advise on the Kentucky Department of Education's future direction and strategic plan.

**Job Description:**

Collaborate with the Deputy Commissioner (and staff) from the Kentucky Department of Education, the Office of Teaching and Learning, the Division of Educator Recruitment, the Division of Student Success on Social and Emotional Learning (with the end goal of implementing state-wide frameworks/standards) and other offices at the Kentucky Department of Education as necessary.

Help develop tools that will help the office support the Coronavirus Response and Relief Supplemental Appropriations (CRRSA) teams on desk monitoring for a minimum of three and no more than five school districts per year (which includes policies, procedures, academic achievement, behavior, trauma-informed practices, attendance and participation in rigorous courses and Career and Technical Education (CTE) pathways).

Present to stakeholders about various topics to create understanding and ask for input (as needed and requested).

Collaborate with schools, districts, regional educational cooperatives and the CRRSA teams to support the implementation of culturally proficient/sustaining multi-tiered systems of support.

Collaborate with the schools districts, regional educational cooperatives and the CRRSA teams and other co-op staff to provide resources to model the creation and implementation of an inclusive curricula tool connected to Kentucky Academic Standards for schools and districts.

Partner with academic consultants in the Office of Teaching and Learning to create a tool that ensure standards are inclusive and relevant to the lives of traditionally underrepresented students and shares this work with key district leaders.

Support development and dissemination of KDE's Equity Toolkit (high-quality standards and resources, Equity Dashboard, Equity Playbook, A4 Modules and supporting the Kentucky Academy for Equity in Teaching initiative by working to diversify the educator workforce).

Support the integration and implementation of trauma informed approaches.

Provide information and advocate for the sustainability of recruitment efforts and strategies to bolster our educator preparation programs.

Partner with local colleges/universities to learn how KDE can help provide grow-your-own programs, recruit diverse students to the educational field and learn about their diversity, equity and inclusion initiatives.

Perform other duties as assigned.

#### **SALARY:**

The total contract price is for salary (KDE contract days 68), fringe benefits and school district indirect costs.

The contract cost for 68 days of the district employee's services includes FY 2022 district salary, district level stipend, fringe benefits and school district indirect costs.

The Kentucky Department of Education reserves the right to redirect the scope of work for this Personnel Memorandum of Agreement in order to focus on Senate Bill 1, 2009 and other related activities as appropriate.

**Memorandum of Agreement Standard Terms and Conditions  
Revised December 2019**

**1.00 Effective Date:**

All Memorandum of Agreements are not effective until the Secretary of the Finance and Administration Cabinet or his authorized designee has approved the agreement and until the agreement has been submitted to the government contract review committee. However, in accordance with KRS 45A.700, memoranda of agreement in aggregate amounts of \$50,000 or less are exempt from review by the committee and need only be filed with the committee within 30 days of their effective date for informational purposes.

KRS 45A.695(7) provides that payments on personal service contracts and memoranda of agreement shall not be authorized for services rendered after government contract review committee disapproval, unless the decision of the committee is overridden by the Secretary of the Finance and Administration Cabinet or agency head, if the agency has been granted delegation authority by the Secretary.

**2.00 EEO Requirements**

The Equal Employment Opportunity Act of 1978 applies to All State government projects with an estimated value exceeding \$500,000. The contractor shall comply with all terms and conditions of the Act.

**3.00 Cancellation clause:**

Both parties shall have the right to terminate and cancel this contract at any time not to exceed thirty (30) days' written notice served on the other party by registered or certified mail.

**4.00 Funding Out Provision:**

The state agency may terminate this agreement if funds are not appropriated to the contracting agency or are not otherwise available for the purpose of making payments without incurring any obligation for payment after the date of termination, regardless of the terms of the agreement. The state agency shall provide the Contractor thirty (30) calendar day's written notice of termination of the agreement due to lack of available funding.

**5.00 Reduction in Contract Worker Hours:**

The Kentucky General Assembly may allow for a reduction in contract worker hours in conjunction with a budget balancing measure for some professional and non-professional

service contracts. If under such authority the agency is required by Executive Order or otherwise to reduce contract hours, the agreement will be reduced by the amount specified in that document. If the contract funding is reduced, then the scope of work related to the contract may also be reduced commensurate with the reduction in funding. This reduction of the scope shall be agreeable to both parties and shall not be considered a breach of contract.

#### **6.00 Access to Records:**

The Contractor also recognizes that any books, documents, papers, records, or other evidence, received during a financial audit or program review shall be subject to the Kentucky Open Records Act, KRS 61.870 to 61.884. Records and other prequalification information confidentially disclosed as part of the bid process shall not be deemed as directly pertinent to the agreement and shall be exempt from disclosure as provided in KRS 61.878(1)(c).

#### **7.00 Violation of tax and employment laws:**

KRS 45A.485 requires the Contractor and all subcontractors performing work under the agreement to reveal to the Commonwealth, prior to the award of a contract, any final determination of a violation by the Contractor within the previous five (5) year period of the provisions of KRS chapters 136, 139, 141, 337, 338, 341, and 342. These statutes relate to corporate and utility tax, sales and use tax, income tax, wages and hours laws, occupational safety and health laws, unemployment insurance laws, and workers compensation insurance laws, respectively.

To comply with the provisions of KRS 45A.485, the Contractor and all subcontractors performing work under the agreement shall report any such final determination(s) of violation(s) to the Commonwealth by providing the following information regarding the final determination(s): the KRS violated, the date of the final determination, and the state agency which issued the final determination.

The Contractor agrees to post in conspicuous places,

In the event of the Contractor's noncompliance with the nondiscrimination clauses of this agreement or with any of the said rules, regulations or orders, this agreement may be cancelled, terminated or suspended in whole or in part and the Contractor may be declared ineligible for further government contracts or federally-assisted construction contracts in accordance with procedures authorized in Executive Order No. 11246 of September 24, 1965, as amended, and such other sanctions may be imposed and remedies invoked as provided in or as otherwise provided by law.

The Contractor will include the provisions of paragraphs (1) through (7) of section 202 of Executive Order 11246 in every subcontract or purchase order unless exempted by rules, regulations or orders of the Secretary of Labor, issued pursuant to section 204 of Executive Order No. 11246 of September 24, 1965, as amended, so that such provisions will be binding upon each subcontractor or vendor.
