7. Principal's Report: (Attachment C)

- **RIT Band Instruction** - RIT band instruction has started in all grade levels. Students are switching classes based on their scores and instructed on their individual needs.
- **Technology** - finalized purchasing laptops for 2:1 for primary - all 3rd -5th have 2019 or newer class sets
- **Volunteer Coordinator** - ordered a new desktop for Katherine Scott, Volunteer Coordinator
- **School Nurse** - ordered a new laptop for Nurse Cindy
- **PD** - recommendation for PD for 2022-23 school year
 - ECE PD (collaboration, interventions, referral process)
 - 3rd and 4th grade will also have SBG days (not sure about K, 1st, and 2nd)
- **Determine funding for needs:**
 - Intervention Support
 - Thomas - Board of Education funded interventionist (reading and/or math) for 3 years
 - Ms. O'Bryan - math interventionist for K-2 grades (No Title 1 funding for next year)
 - Ms. Raymer - early reading intervention (No RTA grant for next year)
- **AR Funding** - Estimated cost for this program is approximately \$10,000 Board of Education will not fund this program next year. However, there are other programs like AR that are free.
- **Playground/School Facilities Plan** - Jim Oliver met with Ms. McGinnis last week to review SCES needs for our playground and school building. SCES is on the 3 year building facilities plan.
- **Budget** - Ms. McGinnis is requesting a balance for all board funding for SCES budgets.

- **Impact Survey Results** -This survey was taken by certified staff. Approximately 75% of SCES certified staff participated. Results are lower than last year. Results were lower across the state as well. Ms. McGinnis will send out the link for the council to review the impact survey results.
- **Retirement** - Ms. McGinnis turned in her letter of retirement to Mr. Abell today. The position for Principal will be posted around March 1st.
