At end of use, customer must clean trailer(s) and equipment 100% before returning, including all grease removed from grease traps, fryers & grease filters and gray water tank 100% drained. Additionally, customer is responsible for draining and winterizing all water lines during cold weather months (Oct.-Mar.). Failure to do so will create additional charges.
