**RECOMMENDATION:**



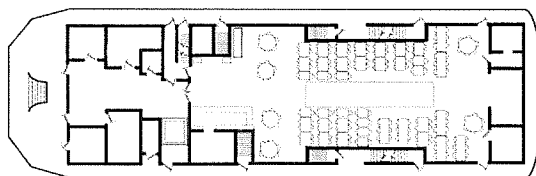

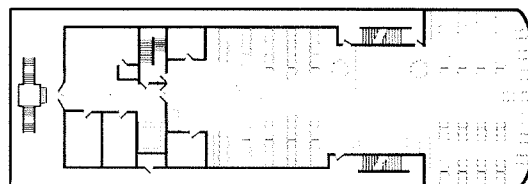

**Newport Deck**

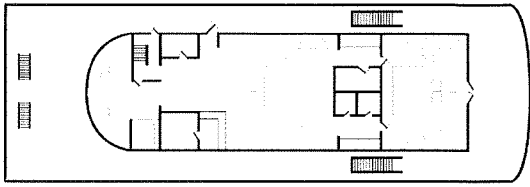


**Covington Deck**
