Policy Description of Tier Definitions

Tier 1

This project review will typically be identical to the present reviews, requiring Schematic, Design Development and Construction Document reviews, post bid and construction submittals, as well as BG-1 through 5 submittals. Examples of Tier One projects are new buildings, additions, and major renovations.

Tier 2

Similar to the above but deleting one design submittal. The BG-2 will be required at Construction Document submittal. Examples of Tier 2 projects are renovations and additions.

Tier 3

Tier 3 reviews require BG-1 through 5, Construction Documents, and Post Bid submittals. Examples of Tier 3 projects are smaller renovations, roofing, and ADA work.

Tier 4

BG-1, 4 and 5 and Owner-Contractor Agreement are required. Examples of Tier 4 projects are minor projects, site acquisition, and roofing.

GESC

GESC projects will continue to be reviewed per the existing GESC checklist.

Cooperative Purchase Agreement (Price Contract), Emergency

Price contract work and Emergency projects will have their own checklists incorporated into the appropriate tier based on scope, funding, etc. as above.
