

The Newport Board of Education held a regular meeting on Wednesday, February 23, 2022, at 6:30 PM. The meeting was held at 30 W. 8th Street, Newport.

CALL TO ORDER

Chairman Malone called the meeting to order and asked for a roll call. The following were present: Ramona Malone, Dr. Julie Smith-Morrow, Melissa Sheffel, Aaron Sutherland, and Sylvia Covington.

Ms. Malone asked those in attendance to stand and recite the Pledge of Allegiance and pause for a Moment of Reflection.

PRESENTATIONS

Mr. Watts recognized Melissa Sheffel for successfully completing another level of the KSBA Academy of Studies during the 2021 calendar year. She was presented with a certificate and a pin.

Mr. Daylin Garland, Lauren O'Brien, and Scott Clark were in attendance to talk about the preservation of the Southgate Street School. The Southgate Street School was opened in the fall of 1866 for African Americans and was run by the Freedmen's Bureau. The government ran out of funds within a couple of years and the school closed. In 1870, the city of Newport purchased the property with the intention of continuing education for African Americans. In 1955 the supreme court made the segregation of educational facilities illegal and the students at this school transferred into local elementary and high schools.

Tonight's guests simply asked the board to consider ways that the district and the preservation committee can work together to restore this historic landmark. Plans are very preliminary at this point.

Many questions and comments were made regarding this endeavor:

- How does the message reach the community to ask for help?
- What is the best way to disseminate information?
- Does the Prince Hall Masonic Lodge own the building or does the City of Newport?
- Preservation should center on education and the history of the school
- How do you start making improvements? Is there a plan in place for what steps to take?
- How do we secure community commitment?
- Is there state funding for preserving historical buildings? National grants?
- Is the building still open as a museum?

Brother Engels, President of the local Prince Hall Masonic Lodge, said the lodge has owned the building since 1955. They have been taking care of maintenance and taxes since that time. Everyone agrees that preservation should be centered around education, which also might be helpful in securing grant funding to improve the structure. To date, the Southgate Street School board does not have concrete plans on how to move on this project. This meeting is informational and for soliciting support and ideas.
