APPLICABLE BOARD POLICY:

01.1 Legal Status of the Board; KRS 116.200

HISTORY/BACKGROUND:

The voting precincts for Kenton County, Kentucky are compiled by the Kenton County Clerk's Office. District Administration along with its legal counsel met with the County Clerk to review proposed changes to the existing School Board Voting Precinct Boundaries. This request was made by the Clerk in order to better organize voting boundaries so that entire cities will be reflected within existing School Board Divisions, create consistency, maintain congruency, and to remove the complexities in some areas (eliminate a single precinct from having two School Board Divisions).



PROPOSED VOTING CHANGES




- A. B107 Edgewood 2 is Division 2 but would like to change to Division 3 **Note: This change would have the whole city of Edgewood in one Division**
- B. A136 Taylor Mill 4 is Division 4 but would like to change to Division 3**Note: This change would have the whole city of Taylor Mill in One Division
- C. Decoursey 1.5 (has 20 people living there) and the upper part of Decoursey are actually part of the City of Taylor Mill and with the redistricting are being put back into the City of Taylor Mill. The new redistricting map will reflect this change. Recommending the parts of Decoursey and Decoursey 1.5 that are Taylor Mill go from Division 1 to Division 3 so that the whole city is under one School Board.
- D. B116 Independence 2 is Division 1 but would like to change to Division 2.
 **Note: This would eliminate this precinct having 2 different school boards in one precinct.
- E. A114 Covington #5 will be renamed Covington 25. The upper part of this precinct is the Covington School Board, so it is cut where it currently becomes Division 4. Recommend to change the part of Covington 15, now Covington 25 from Division 4 to Division 3.
- F. B122 Covington 45 is Division 1 but would like to change to Division 3.

 Note: The changes make more geographic sense for Covington since the precincts above it—Covington 43 and Covington 44 are already Division 3
- G. C102 Crescent Springs 3 is Division 4
 but would like to change to Division 5.
 **Note: This change would have the whole city of Crescent Springs in one Division
- H. B141 Nicholson 3 is Division 1 but would like to change it to Division 2.
 **Note: Nicholson 3 was divided up and the upper part is mainly the City of Independence.


NEW MAP SHOWING CHANGES
