Consent Agenda Item (Action Item): Consider\Approve USAC Form 471 as part of the Federal ERATE Program and Infrastructure replacement project.

Applicable State or Regulations: General Powers and Duties of the Board (01.11)

<u>Fiscal/Budgetary Impact:</u> Per District's USAC funding commitment percentage for Category 2 funds, district's discounted portion of 15% to be paid from General Fund and KETS. If approved, the district's portion will be \$120,156.96 and total project cost is \$801,046.43.

<u>History/Background:</u> Utilizing the Federal ERATE program our district is funded and/or reimbursed 85% of the cost for all ERATE Category 2 eligible equipment. This is all equipment related to our wired and wireless networks (Network switches and Wireless Access Points).

Our current equipment has begun to reach "end of life" and is no longer supported by its manufacturer. By replacing our current soon to be unsupported equipment now we ensure that our technology infrastructure does not become a roadblock for communications and 21st Century learning. Pending Board of Education and USAC approval we can continue to provide students and staff with the best, most reliable user experience utilizing the funds available to us through the ERATE program and replace all our aging network equipment. Our district's current Category 2 ERATE budget also supports complete replacement of all eligible equipment for every district location.

Recommended Action: To approve District's Form 471 for network upgrades.
