### Exceptional Children's Report

1) Special Education Department is in the process of updating procedural processes for referring English Learners for special education services. Our goal is to begin the 2022-23 School Year with revised processes for accurately identifying English Learner (EL) students. We will also revise our process for determining appropriate academic supports once students are eligible for services. Nationally, educators and school psychologist struggle to determine whether a student's academic difficulties stem from a language acquisition need, a learning disability, or some other factor(s). As a result, EL students can be both under- and over-identified for special education services. Our department is working with Kentucky Department of Education personnel and Skip Cleavinger, consultant at Green River Regional Educational Cooperative to increase our professional knowledge in the following areas:

- bilingual language development and disorders in Spanish-English speakers
- assessment/evaluation procedures, identification, and delivery of special education services
- key data needed to inform decision making during referral and eligibility determination meetings
- assessing young children who are dual language learners that exhibit specific set of behavioral and developmental challenges associated with autism spectrum disorders
- adapting specific instructional strategies that are effective for dual language learners when teaching English to children with disabilities

Special Education Department is collaborating with Carla Davis, EL Coordinator to ensure that special education recommendation, procedures, and processes for referring English Learners align with their programming goals/outcomes.

2) Working with Amy Patterson, KDE Systems Exceptional Children Department to review IC reports that list accommodations for students who have IEPs. This system check will ensure any issues regarding accommodations students are eligible to receive for district and state tests are resolved before testing window opens.
