

1 AN ACT relating to educational opportunities, making an appropriation therefor,
2 and declaring an emergency.

3 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

4 ➔Section 1. KRS 160.1590 is amended to read as follows:

5 As used in KRS 160.1590 to 160.1599:

6 (1) ~~["Achievement academy" has the same meaning as "public charter school";~~

7 ~~(2)]~~"Achievement gap" means the difference between performance goals and actual
8 performance on state standardized examinations and other academic performance
9 measures for subgroups of students, especially groups defined by socioeconomic
10 status, race, and ethnicity;

11 ~~(2)~~~~(3)~~ "Applicant" means an eligible person or persons, organization, or entity that
12 seeks approval from a charter school authorizer to establish a public charter school;

13 ~~(3)~~~~(4)~~ "Charter application" means a proposal from an applicant to an authorizer to
14 enter into a charter contract whereby the proposed school obtains public charter
15 school status;

16 ~~(4)~~~~(5)~~ "Charter contract" or "contract" means a fixed-term, renewable contract
17 between a charter school and an authorizer that identifies the roles, powers,
18 responsibilities, and performance expectations for each party to the contract
19 pursuant to KRS 160.1596;

20 ~~(5)~~~~(6)~~ "Charter school board of directors" means the independent board of a public
21 charter school that is party to the charter contract with the authorizer and whose
22 members have been elected or selected pursuant to the school's application;

23 ~~(6)~~~~(7)~~ "Conversion public charter school" means a public charter school that existed
24 as a noncharter public school prior to becoming a public charter school;

25 **(7) "District of location" means the public school district in which a public charter**
26 **school is physically located;**

27 (8) "Education service provider" means an education management organization, school

1 design provider, or any other partner entity with which a public charter school
2 contracts for educational design, implementation, or comprehensive management;

3 (9) "Local school board" or "local board" means a school board exercising
4 management and control of a local school district;

5 (10) "Local school district" means a county or independent school district as identified in
6 KRS 160.010 and 160.020;

7 (11) "Parent" means a parent, guardian, or other person or entity having legal custody of
8 a child;

9 (12) "Private postsecondary institution" means a nonpublic four (4) year university in
10 Kentucky that is nonsectarian in nature, is accredited by a regional accrediting
11 association recognized by the United States Department of Education, and is
12 licensed by the Council on Postsecondary Education;

13 (13) "Proportionate per pupil basis" means multiplying an amount of funds by a
14 fraction, with the numerator being the average daily attendance of the public
15 charter school, and the denominator being the average daily attendance of the
16 school district of location;

17 (14) "Proportionate per pupil transported basis" means multiplying an amount of
18 funds by a fraction, with the numerator being the aggregate daily attendance of
19 students transported by a public charter school, and the denominator being the
20 aggregate daily attendance of students transported by the school district of
21 location;

22 (15)~~(12)~~ "Public charter school" means a public school that:

23 (a) Is a public body corporate and politic, exercising public power, including the
24 power in name to contract and be contracted with, sue and be sued, and adopt
25 bylaws not inconsistent with this section;

26 (b) Has autonomy over decisions, including but not limited to matters concerning
27 finance, personnel, scheduling, curriculum, and instruction;

- 1 (c) Is governed by an independent board of directors;
- 2 (d) Is established and operating under the terms of a charter contract between the
- 3 public charter school's board of directors and its authorizer;
- 4 (e) Is a public school to which parents choose to send their children;
- 5 (f) Is a public school that admits students on the basis of a random and open
- 6 lottery if more students apply for admission than can be accommodated;
- 7 (g) Offers a comprehensive instructional program ***to enrolled students***~~[within a~~
- 8 ~~public school district]~~;
- 9 (h) Operates in pursuit of a specific set of educational objectives as defined in its
- 10 charter contract; and
- 11 (i) Operates under the oversight of its authorizer in accordance with its charter
- 12 contract;

13 **(16)**~~(13)~~ "Public charter school authorizer" or "authorizer" means an entity or body that

14 reviews, approves, or denies charter applications, enters into charter contracts with

15 applicants, oversees public charter schools, and renews, does not renew, or revokes

16 charter contracts. Authorizers ***shall*** include:

- 17 (a) A local school board of a local school district, ***which shall only have***
- 18 ***authority to approve charter applications within the boundaries of its***
- 19 ***district***~~[in which a public charter school is located]~~;
- 20 (b) A collaborative among local school boards that forms to set up a regional
- 21 public charter school to be located within the area managed and controlled by
- 22 those local school boards;
- 23 **(c) *The governing board of a Kentucky public university or a private***
- 24 ***postsecondary institution that elects to become an authorizer, which shall***
- 25 ***have a statewide jurisdiction. The governing board shall elect to become an***
- 26 ***authorizer by adopting a resolution by a majority vote. The governing board***
- 27 ***shall remain an authorizer until such time as the board adopts a resolution***

1 to discontinue being an authorizer by majority vote, however the board shall
 2 still be bound by any charter contract in effect. Any governing board that
 3 seeks to discontinue authorizing activities shall remain an authorizer for
 4 the public charter schools in existence that the board has authorized for the
 5 remainder of the charter contract term. The governing board is authorized
 6 to consider renewals of such charter contracts and shall continue to serve
 7 as an authorizer for those public charter schools until the charter contract
 8 is terminated according to law. The governing board shall submit written
 9 notice of the adoption of authorizer resolutions to the Kentucky Board of
 10 Education;

11 (d) The Kentucky Public Charter School Commission, which shall have a
 12 statewide jurisdiction;

13 (e) The Kentucky Board of Education, which shall have a statewide
 14 jurisdiction;

15 (f) A non-profit entity located in Kentucky established under either KRS
 16 Chapters 273 or 273A that has been approved by the Kentucky Board of
 17 Education. Such an entity shall have statewide jurisdiction. The Kentucky
 18 Board of Education shall promulgate an administrative regulation to
 19 establish an application and approval process and adopt clear and concise
 20 standards for approving nonprofit entities as authorizers;

21 ~~(g)~~~~(e)}~~ The mayor of a consolidated local government, who shall be considered
 22 an authorizer governing board for the purposes of KRS 160.1590 to
 23 160.1599 and who may only authorize public charter schools to be physically
 24 located within the county in which the city is located and who has submitted a
 25 written notice to the state board that he or she intends to serve as an
 26 authorizer; and

27 ~~(h)~~~~(d)}~~ The chief executive officer of an urban-county government, who shall

1 *be considered an authorizer governing board for the purposes of KRS*
 2 *160.1590 to 160.1599 and* who may only authorize public charter schools to
 3 be physically located within the county in which the city is located and who
 4 has submitted a written notice to the state board that he or she intends to serve
 5 as an authorizer;

6 ~~(17)~~~~[(14)]~~ "Qualified teacher" means a person certified by the Education Professional
 7 Standards Board pursuant to KRS 161.028, 161.030, 161.046, or 161.048;

8 ~~[(15) "Regional achievement academy" means a public charter school that has been~~
 9 ~~established to serve students across multiple school districts;]~~

10 ~~(16) "Regional achievement zone" means one (1) county containing four (4) or more~~
 11 ~~local school districts or two (2) or more contiguous counties, each containing four~~
 12 ~~(4) or more local school districts;~~

13 ~~(17) "Start up public charter school" means a public charter school that did not exist as a~~
 14 ~~noncharter public school prior to becoming a public charter school;]~~

15 (18) "State board" means the Kentucky Board of Education;

16 (19) "Student" means any child who is eligible for attendance in a public school in
 17 Kentucky; and

18 (20) "Virtual public charter school" means a public charter school that offers educational
 19 services primarily or completely through an online program.

20 ➔Section 2. KRS 160.1591 is amended to read as follows:

21 (1) The General Assembly hereby finds and declares that:

22 (a) Reducing achievement gaps in Kentucky is necessary for the state to realize its
 23 workforce and economic development potential;

24 (b) Past and current measures have been insufficient for making progress toward
 25 reducing the state's achievement gaps;

26 (c) Additional public school options are necessary to help reduce socioeconomic,
 27 racial, and ethnic achievement gaps; and

- 1 (d) The demand exists for high-quality public charter schools in the
2 Commonwealth.
- 3 (2) The General Assembly hereby establishes a public charter school project to benefit
4 parents, teachers, and community members by creating new, innovative, and more
5 flexible ways of educating all children within the public school system and by
6 advancing a renewed commitment to the mission, goals, and diversity of public
7 education. The purposes of the public charter school initiative are to:
- 8 (a) Improve student learning outcomes by creating additional high-performing
9 schools with high standards for student performance;
- 10 (b) Encourage the use of different, high-quality models of teaching, governing,
11 scheduling, or other aspects of schooling that meet a variety of student needs;
- 12 (c) Close achievement gaps for low-performing groups of public school students;
- 13 (d) Allow schools freedom and flexibility in exchange for exceptional levels of
14 results-driven accountability;
- 15 (e) Increase high-quality educational opportunities within the public education
16 system for all students, especially those at risk of academic failure; and
- 17 (f) Provide students, parents, community members, and local entities with
18 expanded opportunities for involvement in the public education system.
- 19 (3) Beginning in academic year 2022-2023~~[2017-2018]~~, any authorizer may authorize
20 an unlimited number of public charter schools~~[within the boundary of the local~~
21 ~~school district]~~.
- 22 (4) A public charter school shall not be a virtual public charter school.
- 23 (5) ~~[(a) A public charter school authorized by a local school board or collaborative~~
24 ~~may enroll students who reside within the boundaries of the district or districts~~
25 ~~represented by the local school board or collaborative.]~~
- 26 (a)~~[(b)]~~ Enrollment preference for a conversion public charter school shall be
27 given to students who attended the school the previous school year. If the

1 number of students enrolled does not exceed the capacity of the school,
 2 secondary preference shall be given to students who reside within the district
 3 boundary in which the public charter school is located.

4 ~~(b)~~~~(e)~~ Enrollment preference for public charter schools shall be given to
 5 students enrolled in the public charter school the previous year and to siblings
 6 of students already enrolled in the school. ~~The~~~~An~~ enrollment preference for
 7 returning students shall exclude those students from entering into a lottery, as
 8 identified in paragraph ~~(e)~~~~(f)~~ of this subsection.

9 ~~(c)~~~~(d)~~ Enrollment preference may be given to the children of the public charter
 10 school's board of directors and full-time employees of the public charter
 11 school provided they constitute no more than ten percent (10%) of the total
 12 student population.

13 ~~(d)~~~~(e)~~ A public charter school may allow an enrollment preference for students
 14 who meet federal eligibility requirements for free or reduced-price meals and
 15 students who attend persistently low-achieving noncharter public schools.

16 ~~(e)~~~~(f)~~ If capacity is insufficient to enroll all students who wish to attend any
 17 specific grade level or program at a public charter school, the school shall
 18 select students through a randomized and transparent lottery. **The lottery**
 19 **process may allow for siblings in a lottery or different lotteries to be**
 20 **admitted together.**

21 ~~{(6) (a) A public charter school established within the boundaries of a regional~~
 22 ~~achievement zone shall be a regional achievement academy.~~

23 ~~(b) 1. A regional achievement academy may be authorized by a single local~~
 24 ~~school board within the regional achievement zone or by a collaborative~~
 25 ~~of local school boards within the regional achievement zone.~~

 27 ~~board shall be located within the boundaries of the authorizing local~~

9 ~~(6)~~~~[(7)]~~ Consistent with the requirements of KRS 160.1590 to 160.1599 and 161.141,
 10 the state board shall promulgate administrative regulations to guide student
 11 application, lottery, and enrollment in public charter schools.

12 ➔Section 3. KRS 160.1592 is amended to read as follows:

13 (1) A public charter school shall be part of the state's system of public education but
 14 shall be exempt from all statutes and administrative regulations applicable to the
 15 state board, a local school district, or a school, except the public charter school shall
 16 adhere to the same health, safety, civil rights, and disability rights requirements as
 17 are applied to all public schools and to all requirements otherwise identified in KRS
 18 160.1590 to 160.1599 and 161.141.

19 (2) A public charter school may elect to comply with any one (1) or more provisions of
 20 any state statute or administrative regulation.

21 (3) A public charter school shall:

22 (a) Be governed by a board of directors;

23 (b) Be established and operate in pursuit of a specific set of educational objectives
 24 as defined in the charter contract between the school's board of directors and
 25 its authorizer;

26 (c) Ensure students meet compulsory attendance requirements under KRS
 27 158.030 and 158.100 **and record student enrollment and attendance in a**

1 *manner necessary for participation in the fund to support education*
2 *excellence in Kentucky;*

- 3 (d) Hire only qualified teachers to provide student instruction;
- 4 (e) Ensure high school course offerings meet or exceed the minimum required
5 under KRS 156.160 for high school graduation;
- 6 (f) Design its education programs to meet or exceed the student performance
7 standards adopted by the Kentucky Board of Education;
- 8 (g) Ensure students' participation in required state assessment of student
9 performance, as required under KRS 158.6453;
- 10 (h) Adhere to all generally accepted accounting principles and adhere to the same
11 financial audits, audit procedures, and audit requirements as are applied to
12 other public schools under KRS 156.265;
- 13 (i) Utilize the same system for reporting student information data and financial
14 data as is utilized by other school districts across the state;
- 15 (j) Require criminal background checks for staff and volunteers, including
16 members of its governing board, as required of all public school employees
17 and volunteers within the public schools specified in KRS 160.380 and
18 161.148;
- 19 (k) Comply with open records and open meeting requirements under KRS
20 Chapter 61;
- 21 (l) Comply with purchasing requirements and limitations under KRS Chapter
22 45A and KRS 156.074 and 156.480, or provide to the public charter school
23 board of directors a detailed monthly report of school purchases over ten
24 thousand dollars (\$10,000), including but not limited to curriculum, furniture,
25 and technology;
- 26 (m) Provide instructional time that is at least equivalent to the student instructional
27 year specified in KRS 158.070;

- 1 (n) Provide data to the Kentucky Department of Education and the authorizer as
2 required by the Kentucky Department of Education or authorizer to generate a
3 school report card under KRS 158.6453;
- 4 (o) Operate under the oversight of its authorizer in accordance with its charter
5 contract and application;
- 6 (p) As a public body corporate, have all the powers necessary for carrying out the
7 terms of its charter contract, including the power to:
- 8 1. Receive and disburse funds for school purposes;
 - 9 2. Secure appropriate insurance and enter into contracts and leases;
 - 10 3. Contract with an education service provider, provided the board of
11 directors of the public charter school retains oversight and authority over
12 the school;
 - 13 4. Incur debt in reasonable anticipation of the receipt of public or private
14 funds;
 - 15 5. Pledge, assign, or encumber its assets to be used as collateral for loans
16 or extensions of credit;
 - 17 6. Solicit and accept any gifts or grants for school purposes, subject to
18 applicable laws and the terms of its charter;
 - 19 7. Acquire real property for use as its facility or facilities, from public or
20 private sources; and
 - 21 8. Employ or contract with other entities for the provision of teaching,
22 professional, and support staff, as needed; and
- 23 (q) Conduct an admissions lottery if capacity is insufficient to enroll all students
24 who wish to attend the school and ensure that every student has a fair
25 opportunity to be considered in the lottery and that the lottery is competently
26 conducted, equitable, randomized, transparent, impartial, and in accordance
27 with targeted student population and service community as identified in KRS

1 160.1593(3) so that students are accepted in a public charter school without
2 regard to ethnicity, national origin, religion, sex, income level, disabling
3 condition, proficiency in the English language, or academic or athletic ability.

4 (4) For purposes of this subsection, a member of the board of directors of a public
5 charter school shall be considered an officer under KRS 61.040 and shall be
6 removed from office under the statute's provisions.

7 (5) A local school district shall provide or publicize to parents and the general public
8 information about public charter schools authorized by the local school district as an
9 enrollment option within the district to the same extent and through the same means
10 that the school district provides and publicizes information about noncharter public
11 schools in the district.

12 (6) A local school district shall not assign or require any student enrolled in the local
13 school district to attend a public charter school.

14 (7) (a) For purposes of ensuring compliance with this section and the charter under
15 which it operates, a public charter school shall be administered by a public
16 charter school board of directors accountable to the authorizer in a manner
17 agreed to in the charter contract, as negotiated between the public charter
18 school applicant and the authorizer.

19 (b) The board of directors of a public charter school shall consist of a minimum
20 of two (2) parents of students attending any public charter school operating
21 under the direction of the board of directors.

22 (c) A member of the board of directors of a public charter school shall:

23 1. Not be an employee of that school or of an education service provider
24 that provides services to the school; and

25 2. File full disclosure reports and identify any potential conflicts of interest,
26 relationships with management organizations, and relationships with
27 family members who are applying to or are employed by the public

1 charter school or have other business dealings with the school, the
2 management organization of the school, or any other public charter
3 school and shall make these documents available online through the
4 authorizer.

5 (8) Collectively, members of the board of directors shall possess expertise in
6 leadership, curriculum and instruction, law, and finance.

7 (9) (a) A board of directors may hold one (1) or more charter contracts.

8 (b) Each public charter school under contract with a board of directors shall be
9 separate and distinct from any other public charter school under contract with
10 the board of directors.

11 (10) The board of directors shall be responsible for the operation of its public charter
12 school, including but not limited to preparation of a budget, contracting for services,
13 school curriculum, and personnel matters.

14 (11) The board of directors shall:

15 (a) Ensure that all meetings of the board are publicized in advance according to
16 the rules governing the authorizer and are open to the public at times
17 convenient to parents; and

18 (b) Require any education service provider contracted with the board to provide a
19 monthly detailed budget to the board.

20 (12) (a) A public charter school may negotiate and contract with its authorizer or any
21 third party for the use, operation, and maintenance of a building and grounds,
22 liability insurance, and the provision of any service, activity, or undertaking
23 that the public charter school is required to perform in order to carry out the
24 educational program described in its charter. Any services for which a public
25 charter school contracts with a school district shall be provided by the district
26 at cost and shall be negotiated as a separate agreement after final charter
27 contract negotiations. The public charter school shall have standing to sue and

1 be sued in its own name for the enforcement of any contract under color of
2 authority granted by KRS 160.1590 to 160.1599. A public charter school may
3 own, rent, or lease its space.

4 (b) Any entity contracted to provide educational services or goods to a public
5 charter school in an amount exceeding ten thousand dollars (\$10,000) shall be
6 subject to the Open Records Act under KRS Chapter 61 for all records
7 associated with the public charter school contract.

8 (13) A public charter school shall be exempt from administrative regulations governing
9 public schools for purposes of zoning and local land use regulation. The Finance
10 and Administration Cabinet shall annually publish a list of vacant and unused
11 buildings and vacant and unused portions of buildings that are owned by the state
12 and that may be suitable for the operation of a public charter school and shall
13 provide the list to applicants for public charter schools and to existing public charter
14 schools upon request.

15 (14) A public charter school shall be nonsectarian in its programs, admissions policies,
16 employment practices, partnerships, and all other operations and shall not have
17 entrance requirements or charge tuition or fees, except that a public charter school
18 may require the payment of fees on the same basis and to the same extent as other
19 public schools.

20 (15) A public charter school shall not discriminate against any student, employee, or any
21 other person on the basis of ethnicity, religion, national origin, sex, disability,
22 special needs, athletic ability, academic ability, or any other ground that would be
23 unlawful if done by a public school.

24 (16) A public charter school shall serve one (1) or more of grades kindergarten through
25 twelve (12) and shall limit admission to students within the grade levels served.

26 (17) A public charter school shall provide programs and services to a student with a
27 disability in accordance with the student's individualized education program and all

1 federal and state laws, rules, and regulations. A public charter school shall deliver
2 the services directly or contract with another provider to deliver the services. A
3 public charter school shall establish an admissions and release committee at the
4 school and the committee shall:

5 (a) Develop an individualized education program for each student with a
6 disability; or

7 (b) Review, revise, or utilize a student's individualized education program
8 completed by the admissions and release committee of the student's former
9 school. If needed, the committee shall work collaboratively with staff from the
10 student's former school to review and revise a student's existing individualized
11 education program.

12 (18) (a) A public charter school shall be eligible to participate in state-sponsored or
13 district-sponsored interscholastic athletics, academic programs, competitions,
14 awards, scholarships, and recognition programs for students, educators,
15 administrators, and schools to the same extent as noncharter public schools.
16 Participants shall comply with eligibility requirements of students enrolled in
17 noncharter public schools.

18 (b) A public charter school has no obligation to provide extracurricular activities
19 or access to facilities for students enrolled in the public charter school.

20 (c) If a public charter school sponsors interscholastic athletic activities, students
21 enrolled in the public charter school shall be considered eligible to participate
22 in interscholastic competitions by the Kentucky Board of Education or the
23 agency designated by the state board to manage interscholastic athletics, if
24 other eligibility requirements are met. A student enrolled in a public charter
25 school that sponsors an interscholastic athletic activity shall be ineligible to
26 participate in that activity at any other school.

27 (d) If a public charter school does not offer any interscholastic athletic activity

1 sanctioned by the Kentucky Board of Education or the agency designated by
2 the state board to manage interscholastic athletics, a student enrolled in the
3 public charter school shall be eligible to participate at the school the student
4 would attend based on the student's residence.

5 (e) If a public charter school offers any interscholastic athletic activity sanctioned
6 by the Kentucky Board of Education or the agency designated by the state
7 board to manage interscholastic athletics, a student enrolled in the public
8 charter school shall be ineligible to participate in any interscholastic athletic
9 activity at any other school.

10 (19) Nothing in this section shall be construed to prevent the establishment of a single-
11 sex public charter school consistent with federal regulations or a public charter
12 school designed to provide expanded learning opportunities for students at risk of
13 academic failure or for students with special needs.

14 (20) The authorizer of a public charter school shall semiannually consider for approval a
15 public charter school's proposed amendments to a charter contract. The authorizer
16 may consider requests for amendments more frequently upon mutual agreement
17 between the authorizer and the public charter school. The denial of an amendment
18 request is appealable pursuant to KRS 160.1595.

19 (21) If a student who was previously enrolled in a public charter school enrolls in
20 another public school located within the state, the new school shall accept any
21 credits earned and grades received by the student in courses or instructional
22 programs while enrolled in the public charter school in a uniform and consistent
23 manner and according to the same criteria that are used to accept credits from other
24 public schools.

25 (22) A teacher employed by a local board of education under a continuing service
26 contract and offered employment with a public charter school shall be granted a two
27 (2) year leave of absence to teach in a public charter school. The leave of absence

1 shall commence on the first day of service to the public charter school. During the
 2 first or second year of the leave of absence, the teacher may notify the local board of
 3 education that the teacher intends to return to a teaching position in the local school
 4 district. The teacher shall be allowed to return to a teaching position in the local
 5 school district at the appropriate salary for the teacher's years of experience and
 6 educational level. After two (2) years on leave, the relationship between the teacher
 7 and the local board of education shall be determined by the local board and the local
 8 board shall notify the teacher of the decision.

9 ➔Section 4. KRS 160.1593 is amended to read as follows:

10 (1) An application to establish a public charter school may be submitted to a public
 11 charter school authorizer by teachers, parents, school administrators, community
 12 residents, public organizations, nonprofit organizations, or a combination thereof.

13 (2) An applicant shall submit an application for approval of a public charter school to
 14 an authorizer and, if the authorizer is not the Kentucky Public Charter School
 15 Commission or the Kentucky Board of Education, then the applicant shall also
 16 submit a written notification of the application simultaneously to the commission
 17 and state board as a record of the filing. Charter authorizers shall accept and
 18 document the date and time of receipt of all charter applications.

19 (3) The information provided in the application shall be consistent with this section and
 20 shall include:

21 (a) A mission statement and a vision statement for the public charter school,
 22 including the targeted student population and the community the school hopes
 23 to serve, and will outline how the public charter school shall establish
 24 resident and nonresident enrollment policies which shall be subject to the
 25 same limitations as a school district;

26 (b) A description of the school's proposed academic program that is aligned with
 27 state standards, and that implements one (1) or more of the purposes described

- 1 in KRS 160.1591, and the instructional methods that will support the
 2 implementation and success of the program;
- 3 (c) 1. The student achievement goals for the public charter school's
 4 educational program and the chosen methods of evaluating whether
 5 students have attained the skills and knowledge specified for those

24 (11) Funds identified for transfer by a district of location to a public charter school
25 under this section shall be transferred throughout the school year according to a
26 schedule determined by the state board. The scheduled dates shall be within thirty
27 (30) days of the dates of state disbursement of funds to school districts. Failure to

1 transfer required funds shall, for every five (5) days late, result in a fine to the

25 shall petition to Circuit Court of the county in which the public charter school is

14 **(17)** ~~[(5)]~~ By August 31, **2023**~~[2019]~~, and annually thereafter, each public charter school
 15 authorizer shall submit to the commissioner of education, the secretary of the
 16 Education and Workforce Development Cabinet, and the Interim Joint Committee
 17 on Education a report to include:

18 (a) The names of each public charter school operating under contract with the
 19 authorizer during the previous academic year that:

- 20 1. Closed during or after the academic year; or
- 21 2. Had the contract nonrenewed or revoked;

22 (b) The names of each public charter school operating under contract with the
 23 authorizer during the previous academic year that have not yet begun to
 24 operate;

25 (c) The number of applications received, the number reviewed, and the number
 26 approved;

27 (d) A summary of the academic and financial performance of each public charter

1 school operated under contract with the authorizer during the previous
2 academic year; and

3 (e) The authorizing duties and functions performed by the authorizer during the
4 previous academic year.

5 ➔Section 8. KRS 160.1597 is amended to read as follows:

6 (1) Upon the approval of a charter contract by a public charter school authorizer, the
7 applicant shall be permitted to operate a public charter school for a term of five (5)

- 16 fair and specific notice from the authorizer.
- 17 (7) An authorizer may take immediate action to revoke a charter contract if a violation
- 18 threatens the health and safety of the students of the public charter school.
- 19 (8) The State Board of Education shall promulgate administrative regulations
- 20 establishing a revocation and nonrenewal process for charter authorizers that:
- 21 (a) Provides the charter holder with a timely notification of the prospect of
- 22 revocation or nonrenewal and of the reasons for such possible closure;
- 23 (b) Allows a charter holder a reasonable time in which to prepare a response;
- 24 (c) Provides the charter holder with an opportunity to submit documentation and
- 25 provide testimony challenging the rationale behind the closure and in support
- 26 of the continuation of the school at ~~a[an]~~ **public meeting** ~~[orderly proceeding]~~
- 27 held for that purpose;

- 1 (d) Allows the charter holder the right to representation by counsel and to call
2 witnesses on behalf of the charter holder;
- 3 (e) Permits the recording of such proceedings; and
- 4 (f) After a reasonable period of deliberation, requires a final determination be
5 made and conveyed in writing to the charter holder.
- 6 (9) If an authorizer revokes or does not renew a contract, the authorizer shall clearly
7 state, in a resolution of its governing board the reason for the revocation or
8 nonrenewal.
- 9 (10) Within ten (10) days of taking action to renew, not renew, or revoke a charter, the
10 authorizer shall report to the *Kentucky Public Charter School Commission and the*

 11 district. Upon a vacancy, the Speaker of the House and the President of the
 12 Senate may submit recommended appointments to the Governor; and

13 (b) The commissioner of education or the commissioner's designee;

14 (3) (a) Each appointed member of the commission shall satisfy the following
 15 requirements:

16 1. Be a citizen of Kentucky;

17 2. Possess experience and expertise in:

18 a. Public or nonprofit governance;

19 b. Management and finance;

20 c. Public school leadership;

21 d. Assessment, curriculum, or instruction; or

23 3. Have stated a commitment to charter schooling as an effective strategy
 24 for strengthening public education.

25 (b) No more than three (3) of the appointed members of the commission shall
 26 be of the same political party.

27 (c) The appointed members shall reside in geographically diverse areas of the

1 state.

2 (d) No person shall be appointed who holds any other public office or public
3 employment under the government of the Commonwealth or any of its
4 political subdivisions, or who is an appointee or employee of any charter
5 school board of directors or an immediate family member of an employee
6 under the jurisdiction of the commission or any public charter school board
7 of directors.

8 (e) No person shall be appointed who is engaged in, or employed by, a person
9 or company with a primary function that involves the sale of services and
10 activities to public charter schools or charter school boards of directors.

11 (4) Three (3) of the initial appointments shall be for two (2) year terms and three (3)
12 of the initial appointments shall be for one (1) year terms. Thereafter, all
13 appointments shall be for two (2) year terms. The initial appointments shall be
14 made before August 1, 2022, and the commission shall meet within one (1)
15 month at the call of the Governor to organize and select a chair. A vacancy on the
16 commission shall be filled for the remainder of the unexpired term in the same
17 manner as the original appointment. An appointed member shall not serve more
18 than two (2) consecutive full terms, except that a member may be reappointed
19 after a break in service of one (1) full term.

20 (5) The commission shall annually elect a chairperson.

21 (6) An appointed member of the commission may be removed from office by the
22 Governor for official misconduct, incompetence, neglect of duty, or gross
23 immorality. An appointed member may also be removed if the member's personal
24 incapacity renders the member incapable or unfit to discharge the duties of the
25 office or if the member is absent from a number of commission meetings as
26 established in commission bylaws.

27 (7) Except in the case of gross negligence or reckless disregard of the safety and

1 well-being of another person, the commission and members of the commission in
2 their official capacity are immune from civil liability with respect to all activities
3 related to a public charter schools authorized by the commission.

4 (8) The commission shall employ and fix the compensation of an executive director,
5 who shall be its secretary and principal executive officer. The executive director
6 shall demonstrate an understanding of public charter schools as a strategy for
7 strengthening public education and shall possess an understanding of state and
8 federal education law. The executive director shall be responsible for:

9 (a) Organizing and staffing meetings of the commission;

10 (b) Establishing policies to ensure retention of charter appeals documentation;

11 (c) Ensuring that minutes and other financial, procedural, appeal, and
12 operational records are securely maintained and archived;

13 (d) Producing internal and external correspondence and communication;

14 (e) Submitting reports and agenda items for review and approval;

15 (f) Assisting the commission in conducting the business of the commission;

16 (g) Carrying out policy and directives of the commission;

17 (h) Preparing budget submissions;

18 (i) Ensuring that charter appeals are provided to the commission and
19 arranging for independent reviews of appeals as needed;

20 (j) Ensuring that an independent audit of commission finances is conducted
21 biennially;

22 (k) Ensuring that formal written agreements are executed for the procurement
23 of administrative and legal services;

24 (l) Formalizing office policies and procedures relating to charter authorizer
25 and financial operations;

26 (m) Developing and implementing a process for monitoring expenditures and
27 reconciling on a monthly basis commission fund receipts; and

1 (n) Other activities necessary to ensure that the commission meets its
 2 designated duties and responsibilities.

3 (9) The commission shall have full authority to employ and fix the compensation for
 4 any personnel, including counsel, as it may deem necessary to effectively
 5 administer and conduct its duties. The commission shall obtain office space,
 6 furniture, stationery, and any other proper supplies and conveniences reasonably
 7 necessary to carry out its duties.

8 (10) The commission shall promulgate administrative regulations in accordance with
 9 KRS Chapter 13A to establish:

10 1. Commission operating and accountability procedures;

11 2. Appeals procedures in compliance with Section 6 of this Act;

12 3. Oversight standards and procedures for public charter schools which the
 13 commission has authorized or shares joint oversight with an authorizer
 14 pursuant to Section 5 of this Act; and

15 4. Procedures for the collection and accounting of authorizer fees collected by
 16 the commission.

17 (11) The commission shall hold meetings at least four (4) times a year and as
 18 frequently as it deems necessary at the times and places within this state as the
 19 commission may designate. The majority of the voting members shall constitute a
 20 quorum and all meetings shall be conducted in accordance with the Open
 21 Meetings Act, KRS 61.805 to 61.850.

22 (12) The commission may sue and be sued in its own name.

23 (13) Commission members shall receive a per diem of one hundred dollars (\$100) for
 24 attendance at each commission meeting and may be reimbursed for ordinary
 25 travel and other expenses while engaged in the business of the commission.

26 ➔Section 12. KRS 161.141 is amended to read as follows:

27 (1) As used in this section, "education service provider," "public charter school,"

1 "local school board," and "local school district" have the same meanings as in KRS
2 160.1590.

3 (2) (a) Public charter school employees shall participate in the Teachers' Retirement
4 System or the County Employees Retirement System, as determined by their
5 eligibility for participation in the appropriate system and provided the public
6 charter school satisfies the criteria set by the Internal Revenue Service to
7 participate in a governmental retirement plan.

8 (b) Teachers and other certified personnel shall make any required employee
9 contributions to the Teachers' Retirement System under KRS 161.220 to
10 161.716.

11 (c) Classified employees shall make any required employee contributions to the
12 County Employees Retirement System under KRS 78.510 to 78.852.

13 (d) A public charter school shall participate in the state-sponsored health
14 insurance program on the same basis as a local school district pursuant to
15 Sections 13 of this Act.

16 (e) Any state appropriation for retirement, health, or life insurance benefits
17 made on behalf of a local public employee or a school district employee
18 shall also be made on behalf of a public charter school employee.

19 (f) A public charter school shall make any required employer contributions to
20 the Teachers' Retirement System under KRS 161.220 to 161.716 and the
21 County Employees Retirement System under KRS 78.510 to 78.852 in the
22 same manner as local school districts.

23 (g) For the purposes of calculating sick leave credit under KRS 161.220 to
24 161.716, teachers and other certified personnel of a public charter school
25 shall not accumulate more days of sick leave during their employment with
26 the public charter school than they would have otherwise accumulated as a
27 certified employee of the school district of location.

1 (3) (a) A public charter school employee shall not be required to be a member of any
2 collective bargaining agreement.

3 (b) A public charter school employee who enters into any collective bargaining
4 unit must do so as a separate unit from the local school district.

5 (4) A local school board shall not require any employee of the local school district to be
6 employed in a public charter school or any student enrolled in the school district to
7 attend a public charter school.

8 (5) A local school board shall not harass, threaten, discipline, discharge, retaliate, or in
9 any manner discriminate against any district employee involved directly or
10 indirectly with an application to establish a public charter school.

11 **(6) An employee of an education service provider shall not be considered a public**
12 **charter school employee, but shall meet the same certification and background**
13 **check requirements otherwise required of a public charter school employee.**

14 ➔Section 13. KRS 18A.225 is amended to read as follows:

15 (1) (a) The term "employee" for purposes of this section means:

16 1. Any person, including an elected public official, who is regularly
17 employed by any department, office, board, agency, or branch of state
18 government; or by a public postsecondary educational institution; or by
19 any city, urban-county, charter county, county, or consolidated local
20 government, whose legislative body has opted to participate in the state-
21 sponsored health insurance program pursuant to KRS 79.080; and who
22 is either a contributing member to any one (1) of the retirement systems
23 administered by the state, including but not limited to the Kentucky

3 participate in a retirement plan established by an employer who ceases
4 participating in the Kentucky Employees Retirement System pursuant to
5 KRS 61.522 whose employees participated in the health insurance plans
6 administered by the Personnel Cabinet prior to the employer's effective
7 cessation date in the Kentucky Employees Retirement System;
- 8 2. Any certified or classified employee of a local board of education **or a**
9 **public charter school as defined in Section 1 of this Act;**
- 10 3. Any elected member of a local board of education;
- 11 4. Any person who is a present or future recipient of a retirement
12 allowance from the Kentucky Retirement Systems, County Employees
13 Retirement System, Kentucky Teachers' Retirement System, the
14 Legislators' Retirement Plan, the Judicial Retirement Plan, or the
15 Kentucky Community and Technical College System's optional
16 retirement plan authorized by KRS 161.567, except that a person who is
17 receiving a retirement allowance and who is age sixty-five (65) or older
18 shall not be included, with the exception of persons covered under KRS
19 61.702(4)(c), unless he or she is actively employed pursuant to
20 subparagraph 1. of this paragraph; and
- 21 5. Any eligible dependents and beneficiaries of participating employees
22 and retirees who are entitled to participate in the state-sponsored health
23 insurance program;
- 24 (b) The term "health benefit plan" for the purposes of this section means a health
25 benefit plan as defined in KRS 304.17A-005;
- 26 (c) The term "insurer" for the purposes of this section means an insurer as defined
27 in KRS 304.17A-005; and

- 1 (d) The term "managed care plan" for the purposes of this section means a
2 managed care plan as defined in KRS 304.17A-500.
- 3 (2) (a) The secretary of the Finance and Administration Cabinet, upon the
4 recommendation of the secretary of the Personnel Cabinet, shall procure, in
5 compliance with the provisions of KRS 45A.080, 45A.085, and 45A.090,
6 from one (1) or more insurers authorized to do business in this state, a group
7 health benefit plan that may include but not be limited to health maintenance
8 organization (HMO), preferred provider organization (PPO), point of service
9 (POS), and exclusive provider organization (EPO) benefit plans encompassing
10 all or any class or classes of employees. With the exception of employers
11 governed by the provisions of KRS Chapters 16, 18A, and 151B, all
12 employers of any class of employees or former employees shall enter into a
13 contract with the Personnel Cabinet prior to including that group in the state
14 health insurance group. The contracts shall include but not be limited to
15 designating the entity responsible for filing any federal forms, adoption of
16 policies required for proper plan administration, acceptance of the contractual
17 provisions with health insurance carriers or third-party administrators, and
18 adoption of the payment and reimbursement methods necessary for efficient
19 administration of the health insurance program. Health insurance coverage
20 provided to state employees under this section shall, at a minimum, contain
21 the same benefits as provided under Kentucky Kare Standard as of January 1,
22 1994, and shall include a mail-order drug option as provided in subsection
23 (13) of this section. All employees and other persons for whom the health care
24 coverage is provided or made available shall annually be given an option to
25 elect health care coverage through a self-funded plan offered by the
26 Commonwealth or, if a self-funded plan is not available, from a list of
27 coverage options determined by the competitive bid process under the

1 provisions of KRS 45A.080, 45A.085, and 45A.090 and made available
2 during annual open enrollment.

3 (b) The policy or policies shall be approved by the commissioner of insurance and
4 may contain the provisions the commissioner of insurance approves, whether
5 or not otherwise permitted by the insurance laws.

6 (c) Any carrier bidding to offer health care coverage to employees shall agree to
7 provide coverage to all members of the state group, including active
8 employees and retirees and their eligible covered dependents and
9 beneficiaries, within the county or counties specified in its bid. Except as
10 provided in subsection (20) of this section, any carrier bidding to offer health
11 care coverage to employees shall also agree to rate all employees as a single
12 entity, except for those retirees whose former employers insure their active
13 employees outside the state-sponsored health insurance program.

14 (d) Any carrier bidding to offer health care coverage to employees shall agree to
15 provide enrollment, claims, and utilization data to the Commonwealth in a
16 format specified by the Personnel Cabinet with the understanding that the data
17 shall be owned by the Commonwealth; to provide data in an electronic form
18 and within a time frame specified by the Personnel Cabinet; and to be subject
19 to penalties for noncompliance with data reporting requirements as specified
20 by the Personnel Cabinet. The Personnel Cabinet shall take strict precautions
21 to protect the confidentiality of each individual employee; however,
22 confidentiality assertions shall not relieve a carrier from the requirement of
23 providing stipulated data to the Commonwealth.

24 (e) The Personnel Cabinet shall develop the necessary techniques and capabilities
25 for timely analysis of data received from carriers and, to the extent possible,
26 provide in the request-for-proposal specifics relating to data requirements,
27 electronic reporting, and penalties for noncompliance. The Commonwealth

1 shall own the enrollment, claims, and utilization data provided by each carrier
2 and shall develop methods to protect the confidentiality of the individual. The
3 Personnel Cabinet shall include in the October annual report submitted
4 pursuant to the provisions of KRS 18A.226 to the Governor, the General
5 Assembly, and the Chief Justice of the Supreme Court, an analysis of the
6 financial stability of the program, which shall include but not be limited to
7 loss ratios, methods of risk adjustment, measurements of carrier quality of
8 service, prescription coverage and cost management, and statutorily required
9 mandates. If state self-insurance was available as a carrier option, the report
10 also shall provide a detailed financial analysis of the self-insurance fund
11 including but not limited to loss ratios, reserves, and reinsurance agreements.

12 (f) If any agency participating in the state-sponsored employee health insurance
13 program for its active employees terminates participation and there is a state
14 appropriation for the employer's contribution for active employees' health
15 insurance coverage, then neither the agency nor the employees shall receive
16 the state-funded contribution after termination from the state-sponsored
17 employee health insurance program.

18 (g) Any funds in flexible spending accounts that remain after all reimbursements
19 have been processed shall be transferred to the credit of the state-sponsored
20 health insurance plan's appropriation account.

21 (h) Each entity participating in the state-sponsored health insurance program shall
22 provide an amount at least equal to the state contribution rate for the employer
23 portion of the health insurance premium. For any participating entity that used
24 the state payroll system, the employer contribution amount shall be equal to
25 but not greater than the state contribution rate.

26 (3) The premiums may be paid by the policyholder:

27 (a) Wholly from funds contributed by the employee, by payroll deduction or

- 1 otherwise;
- 2 (b) Wholly from funds contributed by any department, board, agency, public
3 postsecondary education institution, or branch of state, city, urban-county,
4 charter county, county, or consolidated local government; or
- 5 (c) Partly from each, except that any premium due for health care coverage or
6 dental coverage, if any, in excess of the premium amount contributed by any
7 department, board, agency, postsecondary education institution, or branch of
8 state, city, urban-county, charter county, county, or consolidated local
9 government for any other health care coverage shall be paid by the employee.
- 10 (4) If an employee moves his or her place of residence or employment out of the service
11 area of an insurer offering a managed health care plan, under which he or she has
12 elected coverage, into either the service area of another managed health care plan or
13 into an area of the Commonwealth not within a managed health care plan service
14 area, the employee shall be given an option, at the time of the move or transfer, to
15 change his or her coverage to another health benefit plan.
- 16 (5) No payment of premium by any department, board, agency, public postsecondary
17 educational institution, or branch of state, city, urban-county, charter county,
18 county, or consolidated local government shall constitute compensation to an
19 insured employee for the purposes of any statute fixing or limiting the
20 compensation of such an employee. Any premium or other expense incurred by any
21 department, board, agency, public postsecondary educational institution, or branch
22 of state, city, urban-county, charter county, county, or consolidated local
23 government shall be considered a proper cost of administration.
- 24 (6) The policy or policies may contain the provisions with respect to the class or classes
25 of employees covered, amounts of insurance or coverage for designated classes or
26 groups of employees, policy options, terms of eligibility, and continuation of
27 insurance or coverage after retirement.

- 1 (7) Group rates under this section shall be made available to the disabled child of an
2 employee regardless of the child's age if the entire premium for the disabled child's
3 coverage is paid by the state employee. A child shall be considered disabled if he or
4 she has been determined to be eligible for federal Social Security disability benefits.
- 5 (8) The health care contract or contracts for employees shall be entered into for a period
6 of not less than one (1) year.
- 7 (9) The secretary shall appoint thirty-two (32) persons to an Advisory Committee of
8 State Health Insurance Subscribers to advise the secretary or the secretary's designee
9 regarding the state-sponsored health insurance program for employees. The
10 secretary shall appoint, from a list of names submitted by appointing authorities,
11 members representing school districts from each of the seven (7) Supreme Court
12 districts, members representing state government from each of the seven (7)
13 Supreme Court districts, two (2) members representing retirees under age sixty-five
14 (65), one (1) member representing local health departments, two (2) members
15 representing the Kentucky Teachers' Retirement System, and three (3) members at
16 large. The secretary shall also appoint two (2) members from a list of five (5) names
17 submitted by the Kentucky Education Association, two (2) members from a list of
18 five (5) names submitted by the largest state employee organization of nonschool
19 state employees, two (2) members from a list of five (5) names submitted by the
20 Kentucky Association of Counties, two (2) members from a list of five (5) names
21 submitted by the Kentucky League of Cities, and two (2) members from a list of
22 names consisting of five (5) names submitted by each state employee organization
23 that has two thousand (2,000) or more members on state payroll deduction. The
24 advisory committee shall be appointed in January of each year and shall meet
25 quarterly.
- 26 (10) Notwithstanding any other provision of law to the contrary, the policy or policies
27 provided to employees pursuant to this section shall not provide coverage for

1 obtaining or performing an abortion, nor shall any state funds be used for the
2 purpose of obtaining or performing an abortion on behalf of employees or their
3 dependents.

4 (11) Interruption of an established treatment regime with maintenance drugs shall be
5 grounds for an insured to appeal a formulary change through the established appeal
6 procedures approved by the Department of Insurance, if the physician supervising
7 the treatment certifies that the change is not in the best interests of the patient.

8 (12) Any employee who is eligible for and elects to participate in the state health
9 insurance program as a retiree, or the spouse or beneficiary of a retiree, under any
10 one (1) of the state-sponsored retirement systems shall not be eligible to receive the
11 state health insurance contribution toward health care coverage as a result of any
12 other employment for which there is a public employer contribution. This does not
13 preclude a retiree and an active employee spouse from using both contributions to
14 the extent needed for purchase of one (1) state sponsored health insurance policy for
15 that plan year.

16 (13) (a) The policies of health insurance coverage procured under subsection (2) of
17 this section shall include a mail-order drug option for maintenance drugs for
18 state employees. Maintenance drugs may be dispensed by mail order in
19 accordance with Kentucky law.

20 (b) A health insurer shall not discriminate against any retail pharmacy located
21 within the geographic coverage area of the health benefit plan and that meets
22 the terms and conditions for participation established by the insurer, including
23 price, dispensing fee, and copay requirements of a mail-order option. The
24 retail pharmacy shall not be required to dispense by mail.

25 (c) The mail-order option shall not permit the dispensing of a controlled
26 substance classified in Schedule II.

27 (14) The policy or policies provided to state employees or their dependents pursuant to

1 this section shall provide coverage for obtaining a hearing aid and acquiring hearing
2 aid-related services for insured individuals under eighteen (18) years of age, subject
3 to a cap of one thousand four hundred dollars (\$1,400) every thirty-six (36) months
4 pursuant to KRS 304.17A-132.

5 (15) Any policy provided to state employees or their dependents pursuant to this section
6 shall provide coverage for the diagnosis and treatment of autism spectrum disorders
7 consistent with KRS 304.17A-142.

8 (16) Any policy provided to state employees or their dependents pursuant to this section
9 shall provide coverage for obtaining amino acid-based elemental formula pursuant
10 to KRS 304.17A-258.

11 (17) If a state employee's residence and place of employment are in the same county, and
12 if the hospital located within that county does not offer surgical services, intensive
13 care services, obstetrical services, level II neonatal services, diagnostic cardiac
14 catheterization services, and magnetic resonance imaging services, the employee
15 may select a plan available in a contiguous county that does provide those services,
16 and the state contribution for the plan shall be the amount available in the county
17 where the plan selected is located.

18 (18) If a state employee's residence and place of employment are each located in counties
19 in which the hospitals do not offer surgical services, intensive care services,
20 obstetrical services, level II neonatal services, diagnostic cardiac catheterization
21 services, and magnetic resonance imaging services, the employee may select a plan
22 available in a county contiguous to the county of residence that does provide those
23 services, and the state contribution for the plan shall be the amount available in the
24 county where the plan selected is located.

25 (19) The Personnel Cabinet is encouraged to study whether it is fair and reasonable and
26 in the best interests of the state group to allow any carrier bidding to offer health
27 care coverage under this section to submit bids that may vary county by county or

1 by larger geographic areas.

2 (20) Notwithstanding any other provision of this section, the bid for proposals for health
3 insurance coverage for calendar year 2004 shall include a bid scenario that reflects
4 the statewide rating structure provided in calendar year 2003 and a bid scenario that
5 allows for a regional rating structure that allows carriers to submit bids that may
6 vary by region for a given product offering as described in this subsection:

7 (a) The regional rating bid scenario shall not include a request for bid on a
8 statewide option;

9 (b) The Personnel Cabinet shall divide the state into geographical regions which
10 shall be the same as the partnership regions designated by the Department for
11 Medicaid Services for purposes of the Kentucky Health Care Partnership
12 Program established pursuant to 907 KAR 1:705;

13 (c) The request for proposal shall require a carrier's bid to include every county
14 within the region or regions for which the bid is submitted and include but not
15 be restricted to a preferred provider organization (PPO) option;

16 (d) If the Personnel Cabinet accepts a carrier's bid, the cabinet shall award the
17 carrier all of the counties included in its bid within the region. If the Personnel
18 Cabinet deems the bids submitted in accordance with this subsection to be in
19 the best interests of state employees in a region, the cabinet may award the
20 contract for that region to no more than two (2) carriers; and

21 (e) Nothing in this subsection shall prohibit the Personnel Cabinet from including
22 other requirements or criteria in the request for proposal.

23 (21) Any fully insured health benefit plan or self-insured plan issued or renewed on or
24 after July 12, 2006, to public employees pursuant to this section which provides
25 coverage for services rendered by a physician or osteopath duly licensed under KRS
26 Chapter 311 that are within the scope of practice of an optometrist duly licensed
27 under the provisions of KRS Chapter 320 shall provide the same payment of

1 coverage to optometrists as allowed for those services rendered by physicians or
2 osteopaths.

3 (22) Any fully insured health benefit plan or self-insured plan issued or renewed on or
4 after June 29, 2021, to public employees pursuant to this section shall comply with:

5 (a) KRS 304.12-237;

6 (b) KRS 304.17A-270 and 304.17A-525;

7 (c) KRS 304.17A-600 to 304.17A-633;

8 (d) KRS 205.593;

9 (e) KRS 304.17A-700 to 304.17A-730;

10 (f) KRS 304.14-135;

11 (g) KRS 304.17A-580 and 304.17A-641;

12 (h) KRS 304.99-123;

13 (i) KRS 304.17A-138; and

14 (j) Administrative regulations promulgated pursuant to statutes listed in this
15 subsection.

16 (23) Any fully insured health benefit plan or self-insured plan issued or renewed on or
17 after January 1, 2022, to public employees pursuant to this section shall comply
18 with KRS 304.17A-148.

19 ➔Section 14. KRS 161.220 is amended to read as follows:

20 As used in KRS 161.220 to 161.716 and 161.990:

21 (1) "Retirement system" means the arrangement provided for in KRS 161.220 to
22 161.716 and 161.990 for payment of allowances to members;

23 (2) "Retirement allowance" means the amount annually payable during the course of his
24 or her natural life to a member who has been retired by reason of service;

25 (3) "Disability allowance" means the amount annually payable to a member retired by
26 reason of disability;

27 (4) "Member" means the commissioner of education, deputy commissioners, associate

1 commissioners, and all division directors in the State Department of Education,
2 employees participating in the system pursuant to KRS 196.167(3)(b)1., and any
3 full-time teacher or professional occupying a position requiring certification or
4 graduation from a four (4) year college or university, as a condition of employment,
5 and who is employed by public boards, institutions, or agencies as follows:

- 6 (a) Local boards of education and public charter schools if the public charter
7 school satisfies the criteria set by the Internal Revenue Service to participate

- 9 (b) Eastern Kentucky University, Kentucky State University, Morehead State

16 State of Kentucky whom the board of trustees may designate by administrative
17 regulation;
- 18 (e) Regional cooperative organizations formed by local boards of education or
19 other public educational institutions listed in this subsection, for the purpose
20 of providing educational services to the participating organizations;
- 21 (f) All full-time members of the staffs of the Kentucky Association of School
22 Administrators, Kentucky Education Association, Kentucky Vocational

17 reemployed by an employer identified in this subsection in a position that the
18 board of trustees deems to be a member, except that any person who becomes
19 a member on or after January 1, 2022, and subsequently draws a monthly
20 lifetime retirement allowance, shall upon reemployment after retirement not
21 earn a second retirement account;

24 (p) Employees of the Kentucky Department of Education only who are graduates
25 of a four (4) year college or university, notwithstanding a substitution clause
26 within a job classification, and who are serving in a professional job
27 classification as defined by the department;

- 1 (q) The Governor's School for Entrepreneurs Program;
- 2 (r) Employees of the Office of Adult Education within the Department of
3 Workforce Investment in the Education and Workforce Development Cabinet
4 who were employees of the Council on Postsecondary Education, Kentucky
5 Adult Education Program and who were members of the Kentucky Teachers'
6 Retirement System at the time the Program was transferred to the cabinet
7 pursuant to Executive Orders 2019-0026 and 2019-0027; and
- 8 (s) Employees of the Education Professional Standards Board who were members
9 of the Kentucky Teachers' Retirement System at the time the employees were
10 transferred to the Kentucky Department of Education pursuant to Executive
11 Order 2020-590;
- 12 (5) "Present teacher" means any teacher who was a teacher on or before July 1, 1940,
13 and became a member of the retirement system created by 1938 (1st Extra. Sess.)
14 Ky. Acts ch. 1, on the date of the inauguration of the system or within one (1) year
15 after that date, and any teacher who was a member of a local teacher retirement
16 system in the public elementary or secondary schools of the state on or before July
17 1, 1940, and continued to be a member of the system until he or she, with the
18 membership of the local retirement system, became a member of the state Teachers'
19 Retirement System or who becomes a member under the provisions of KRS
20 161.470(4);
- 21 (6) "New teacher" means any member not a present teacher;
- 22 (7) "Prior service" means the number of years during which the member was a teacher
23 in Kentucky prior to July 1, 1941, except that not more than thirty (30) years' prior
24 service shall be allowed or credited to any teacher;
- 25 (8) "Subsequent service" means the number of years during which the teacher is a
26 member of the Teachers' Retirement System after July 1, 1941;
- 27 (9) "Final average salary" means the average of the five (5) highest annual salaries

1 which the member has received for service in a covered position and on which the
2 member has made contributions, or on which the public board, institution, or
3 agency has picked-up member contributions pursuant to KRS 161.540(2), or the
4 average of the five (5) years of highest salaries as defined in KRS 61.680(2)(a),
5 which shall include picked-up member contributions. Additionally, the board of
6 trustees may approve a final average salary based upon the average of the three (3)
7 highest salaries for individuals who become members prior to January 1, 2022, who
8 are at least fifty-five (55) years of age and have a minimum of twenty-seven (27)
9 years of Kentucky service credit. However, if any of the five (5) or three (3) highest
10 annual salaries used to calculate the final average salary was paid within the three

14 become members on or after January 1, 2022, the amount of salary to be included
15 for each of those three (3) years or five (5) years, as applicable, for the purpose of
16 calculating the final average salary shall be limited to the lesser of:

- 18 (b) The member's annual salary that was used for retirement purposes during each
19 of the prior three (3) years or five (5) years, as applicable, plus a percentage
20 increase equal to the percentage increase received by all other members
21 employed by the public board, institution, or agency, or for members of school
22 districts, the highest percentage increase received by members on any one (1)
23 rank and step of the salary schedule of the school district. The increase shall
24 be computed on the salary that was used for retirement purposes. The board of
25 trustees may promulgate an administrative regulation in accordance with KRS
26 Chapter 13A to establish a methodology for measuring the limitation so that
27 the combined increases in salary for each of the last three (3) full years of

1 salary prior to retirement shall not exceed the total permissible percentage
2 increase received by other members of the employer for the same three (3)
3 year period.

4 For individuals who became members of the retirement system prior to July 1,
5 2021, this limitation shall not apply if the member receives an increase in salary in a
6 percentage exceeding that received by the other members, and this increase was
7 accompanied by a corresponding change in position or in length of employment.
8 The board of trustees may promulgate an administrative regulation in accordance
9 with KRS Chapter 13A to provide definitions for a corresponding change in
10 position or in length of employment. This limitation shall also not apply to the
11 payment to a member for accrued annual leave if the individual becomes a member
12 before July 1, 2008, or accrued sick leave which is authorized by statute and which
13 shall, for individuals subject to KRS 161.155(10) who became nonuniversity
14 members of the system prior to January 1, 2022, be included as part of a retiring
15 member's annual compensation for the member's last year of active service;

16 (10) "Annual compensation" means the total salary received by a member as
17 compensation for all services performed in employment covered by the retirement
18 system during a fiscal year. Annual compensation shall not include payment for any
19 benefit or salary adjustments made by the public board, institution, or agency to the
20 member or on behalf of the member which is not available as a benefit or salary
21 adjustment to other members employed by that public board, institution, or agency.
22 Annual compensation shall not include the salary supplement received by a member
23 under KRS 157.197(2)(c), 158.6455, or 158.782 on or after July 1, 1996. Under no
24 circumstances shall annual compensation include compensation that is earned by a
25 member while on assignment to an organization or agency that is not a public board,
26 institution, or agency listed in subsection (4) of this section. In the event that federal
27 law requires that a member continue membership in the retirement system even

1 though the member is on assignment to an organization or agency that is not a
2 public board, institution, or agency listed in subsection (4) of this section, the
3 member's annual compensation for retirement purposes shall be deemed to be the
4 annual compensation, as limited by subsection (9) of this section, last earned by the
5 member while still employed solely by and providing services directly to a public
6 board, institution, or agency listed in subsection (4) of this section. The board of
7 trustees shall determine if any benefit or salary adjustment qualifies as annual
8 compensation. For an individual who becomes a member on or after July 1, 2008,
9 annual compensation shall not include lump-sum payments upon termination of
10 employment for accumulated annual or compensatory leave;

11 (11) "Age of member" means the age attained on the first day of the month immediately
12 following the birthdate of the member. This definition is limited to retirement
13 eligibility and does not apply to tenure of members;

14 (12) "Employ," and derivatives thereof, means relationships under which an individual
15 provides services to an employer as an employee, as an independent contractor, as
16 an employee of a third party, or under any other arrangement as long as the services
17 provided to the employer are provided in a position that would otherwise be covered
18 by the Kentucky Teachers' Retirement System and as long as the services are being
19 provided to a public board, institution, or agency listed in subsection (4) of this
20 section;

21 (13) "Regular interest" means:

22 (a) For an individual who becomes a member prior to July 1, 2008, interest at
23 three percent (3%) per annum;;

24 (b) For an individual who becomes a member on or after July 1, 2008, but prior to
25 January 1, 2022, interest at two and one-half percent (2.5%) per annum for
26 purposes of crediting interest to the teacher savings account or any other
27 contributions made by the employee that are refundable to the employee upon

- 1 termination of employment; and
- 2 (c) For an individual who becomes a member on or after January 1, 2022, the
- 3 rolling five (5) year yield on a thirty (30) year United States Treasury bond as
- 4 of the end of May prior to the most recently completed fiscal year, except that:
- 5 1. Once the member has at least sixty (60) months of service in the system
- 6 it shall mean interest at two and one-half percent (2.5%) per annum for
- 7 purposes of crediting interest to employee contributions in the
- 8 foundational benefit component or any other contributions made by the
- 9 employee to the foundational benefit component that are refundable to
- 10 the employee upon termination of employment; and
- 11 2. The board shall have the authority to adjust the regular interest rate for
- 12 individuals who become members on or after January 1, 2022, in
- 13 accordance with KRS 161.633 and 161.634;
- 14 (14) "Accumulated contributions" means the contributions of a member to the teachers'
- 15 savings fund, including picked-up member contributions as described in KRS
- 16 161.540(2), plus accrued regular interest;
- 17 (15) "Annuitant" means a person who receives a retirement allowance or a disability
- 18 allowance;
- 19 (16) "Local retirement system" means any teacher retirement or annuity system created
- 20 in any public school district in Kentucky in accordance with the laws of Kentucky;
- 21 (17) "Fiscal year" means the twelve (12) month period from July 1 to June 30. The
- 22 retirement plan year is concurrent with this fiscal year. A contract for a member
- 23 employed by a local board of education may not exceed two hundred sixty-one
- 24 (261) days in the fiscal year;
- 25 (18) "Public schools" means the schools and other institutions mentioned in subsection
- 26 (4) of this section;
- 27 (19) "Dependent" as used in KRS 161.520 and 161.525 means a person who was

1 receiving, at the time of death of the member, at least one-half (1/2) of the support
2 from the member for maintenance, including board, lodging, medical care, and
3 related costs;

4 (20) "Active contributing member" means a member currently making contributions to
5 the Teachers' Retirement System, who made contributions in the next preceding
6 fiscal year, for whom picked-up member contributions are currently being made, or
7 for whom these contributions were made in the next preceding fiscal year;

8 (21) "Full-time" means employment in a position that requires services on a continuing
9 basis equal to at least seven-tenths (7/10) of normal full-time service on a fiscal year
10 basis;

11 (22) "Full actuarial cost," when used to determine the payment that a member must pay
12 for service credit means the actuarial value of all costs associated with the
13 enhancement of a member's benefits or eligibility for benefit enhancements,
14 including health insurance supplement payments made by the retirement system.
15 The actuary for the retirement system shall determine the full actuarial value costs
16 and actuarial cost factor tables as provided in KRS 161.400;

17 (23) "Last annual compensation" means the annual compensation, as defined by
18 subsection (10) of this section and as limited by subsection (9) of this section,
19 earned by the member during the most recent period of contributing service, either
20 consecutive or nonconsecutive, that is sufficient to provide the member with one (1)
21 full year of service credit in the Kentucky Teachers' Retirement System, and which
22 compensation is used in calculating the member's initial retirement allowance,
23 excluding bonuses, retirement incentives, payments for accumulated sick leave,
24 annual, personal, and compensatory leave, and any other lump-sum payment. For an
25 individual who becomes a member on or after July 1, 2008, payments for annual or
26 compensatory leave shall not be included in determining the member's last annual
27 compensation;

- 1 (24) "Participant" means a member, as defined by subsection (4) of this section, or an
2 annuitant, as defined by subsection (15) of this section;
- 3 (25) "Qualified domestic relations order" means any judgment, decree, or order,
4 including approval of a property settlement agreement, that:
- 5 (a) Is issued by a court or administrative agency; and
6 (b) Relates to the provision of child support, alimony payments, or marital
7 property rights to an alternate payee;
- 8 (26) "Alternate payee" means a spouse, former spouse, child, or other dependent of a
9 participant, who is designated to be paid retirement benefits in a qualified domestic
10 relations order;
- 11 (27) "University member" means an individual who becomes a member through
12 employment with an employer specified in subsection (4)(b) and (n) of this section;
- 13 (28) "Nonuniversity member" means an individual who becomes a member through
14 employment with an employer specified under subsection (4) of this section, except
15 for those members employed by an employer specified in subsection (4)(b) and (n)
16 of this section;
- 17 (29) "Accumulated employer contribution" means the employer contribution deposited
18 to a member's account through the supplemental benefit component and regular
19 interest credited on such amounts as provided by KRS 161.635 for nonuniversity
20 members and KRS 161.636 for university members;
- 21 (30) "Accumulated account balance" means:
- 22 (a) For members who began participating in the system prior to January 1, 2022,
23 the member's accumulated contributions; or
24 (b) For members who began participating in the system on or after January 1,
25 2022, the combined sum of the member's accumulated contributions and the
26 member's accumulated employer contributions;
- 27 (31) "Foundational benefit component" means the benefits provided by KRS 161.220 to

1 161.716 to individuals who become members on or after January 1, 2022, except for
2 the supplemental benefit component and retiree health benefits set forth in KRS
3 161.675; and

4 (32) "Supplemental benefit component" means:

5 (a) The benefit established pursuant to KRS 161.635 for individuals who become
6 nonuniversity members on or after January 1, 2022; or

7 (b) The benefit established pursuant to KRS 161.636 for individuals who become
8 university members on or after January 1, 2022.

9 ➔Section 15. KRS 78.510 is amended to read as follows:

10 As used in KRS 78.510 to 78.852, unless the context otherwise requires:

11 (1) "System" means the County Employees Retirement System;

12 (2) "Board" means the board of trustees of the system as provided in KRS 78.782;

13 (3) "County" means any county, or nonprofit organization created and governed by a
14 county, counties, or elected county officers, sheriff and his or her employees, county
15 clerk and his or her employees, circuit clerk and his or her deputies, former circuit

1 **(b) A public charter school as defined in Section 1 of this Act if the public**
2 **charter school satisfies the criteria set by the Internal Revenue Service to**

- 4 (5) "Examiner" means the medical examiners as provided in KRS 61.665;
- 5 (6) "Employee" means every regular full-time appointed or elective officer or employee
6 of a participating county and the coroner of a participating county, whether or not he
7 or she qualifies as a regular full-time officer. The term shall not include persons
8 engaged as independent contractors, seasonal, emergency, temporary, and part-time
9 workers. In case of any doubt, the board shall determine if a person is an employee
10 within the meaning of KRS 78.510 to 78.852;
- 11 (7) "Employer" means a county, as defined in subsection (3) of this section, the elected
12 officials of a county, or any authority of the county having the power to appoint or
13 elect an employee to office or employment in the county;
- 14 (8) "Member" means any employee who is included in the membership of the system or
15 any former employee whose membership has not ceased under KRS 78.535;
- 16 (9) "Service" means the total of current service and prior service as defined in this
17 section;
- 18 (10) "Current service" means the number of years and months of employment as an
19 employee, on and after July 1, 1958, for which creditable compensation is paid and
20 employee contributions deducted, except as otherwise provided;
- 21 (11) "Prior service" means the number of years and completed months, expressed as a
22 fraction of a year, of employment as an employee, prior to July 1, 1958, for which
23 creditable compensation was paid. An employee shall be credited with one (1)
24 month of prior service only in those months he received compensation for at least
25 one hundred (100) hours of work. Twelve (12) months of current service in the
26 system shall be required to validate prior service;
- 27 (12) "Accumulated contributions" means the sum of all amounts deducted from the

1 compensation of a member and credited to his individual account in the members'
2 account, including employee contributions picked up after August 1, 1982, pursuant
3 to KRS 78.610(4), together with interest credited, on the amounts, and any other
4 amounts the member shall have contributed thereto, including interest credited
5 thereon. "Accumulated contributions" shall not include employee contributions that
6 are deposited into accounts established pursuant to 26 U.S.C. sec. 401(h) within the
7 fund established in KRS 78.520, as prescribed by KRS 78.5536(3)(b);

8 (13) "Creditable compensation":

9 (a) Except as limited by paragraph (c) of this subsection, means all salary, wages,
10 and fees, including payments for compensatory time, paid to the employee as
11 a result of services performed for the employer or for time during which the
12 member is on paid leave, which are includable on the member's federal form
13 W-2 wage and tax statement under the heading "wages, tips, other
14 compensation", including employee contributions picked up after August 1,
15 1982, pursuant to KRS 78.610(4). The creditable compensation of fee officers
16 who receive salary, fees, maintenance, or other perquisites as a result of their
17 official duties is the gross amount received decreased by the cost of salary
18 paid deputies and clerks and the cost of office supplies and other official
19 expenses;

20 (b) Includes:

- 21 1. Lump-sum bonuses, severance pay, or employer-provided payments for
22 purchase of service credit, which shall be averaged over the employee's
23 service with the system in which it is recorded if it is equal to or greater

26 but the board shall fix the value of that part of the compensation not paid
27 in money;

- 1 3. Lump-sum payments for creditable compensation paid as a result of an
2 order of a court of competent jurisdiction, the Personnel Board, or the
3 Commission on Human Rights, or for any creditable compensation paid
4 in anticipation of settlement of an action before a court of competent
5 jurisdiction, the Personnel Board, or the Commission on Human Rights,
6 including notices of violations of state or federal wage and hour statutes

18 January 1, 2001, that are not includable in the gross income of the
19 employee by reason of 26 U.S.C. sec. 132(f)(4); and
- 20 (c) Excludes:
- 21 1. Living allowances, expense reimbursements, lump-sum payments for
22 accrued vacation leave, sick leave except as provided in KRS 78.616(5),
23 and other items determined by the board;
- 24 2. For employees who begin participating on or after September 1, 2008,
25 lump-sum payments for compensatory time;
- 26 3. Training incentive payments for city officers paid as set out in KRS
27 64.5277 to 64.5279;

- 1 4. For employees who begin participating on or after August 1, 2016,
2 nominal fees paid for services as a volunteer; and
3 5. Any salary or wages paid to an employee for services as a Kentucky
4 State Police school resource officer as defined by KRS 158.441;

5 (14) "Final compensation" means:

- 6 (a) For a member who begins participating before September 1, 2008, who is
7 employed in a nonhazardous position, the creditable compensation of the
8 member during the five (5) fiscal years he or she was paid at the highest
9 average monthly rate divided by the number of months of service credit during
10 that five (5) year period multiplied by twelve (12). The five (5) years may be
11 fractional and need not be consecutive. If the number of months of service
12 credit during the five (5) year period is less than forty-eight (48), one (1) or
13 more additional fiscal years shall be used;
- 14 (b) For a member who is employed in a nonhazardous position, whose effective
15 retirement date is between August 1, 2001, and January 1, 2009, and whose
16 total service credit is at least twenty-seven (27) years and whose age and years
17 of service total at least seventy-five (75), final compensation means the
18 creditable compensation of the member during the three (3) fiscal years the
19 member was paid at the highest average monthly rate divided by the number
20 of months of service credit during that three (3) year period multiplied by
21 twelve (12). The three (3) years may be fractional and need not be
22 consecutive. If the number of months of service credit during the three (3)
23 year period is less than twenty-four (24), one (1) or more additional fiscal
24 years shall be used;
- 25 (c) For a member who begins participating before September 1, 2008, who is
26 employed in a hazardous position, as provided in KRS 61.592, the creditable
27 compensation of the member during the three (3) fiscal years he or she was

1 paid at the highest average monthly rate divided by the number of months of
2 service credit during that three (3) year period multiplied by twelve (12). The
3 three (3) years may be fractional and need not be consecutive. If the number of
4 months of service credit during the three (3) year period is less than twenty-
5 four (24), one (1) or more additional fiscal years, which may contain less than
6 twelve (12) months of service credit, shall be used;

7 (d) For a member who begins participating on or after September 1, 2008, but
8 prior to January 1, 2014, who is employed in a nonhazardous position, the
9 creditable compensation of the member during the five (5) complete fiscal
10 years immediately preceding retirement divided by five (5). Each fiscal year
11 used to determine final compensation must contain twelve (12) months of
12 service credit. If the member does not have five (5) complete fiscal years that
13 each contain twelve (12) months of service credit, then one (1) or more
14 additional fiscal years, which may contain less than twelve (12) months of
15 service credit, shall be added until the number of months in the final
16 compensation calculation is at least sixty (60) months; or

17 (e) For a member who begins participating on or after September 1, 2008, but
18 prior to January 1, 2014, who is employed in a hazardous position as provided
19 in KRS 61.592, the creditable compensation of the member during the three
20 (3) complete fiscal years he or she was paid at the highest average monthly
21 rate divided by three (3). Each fiscal year used to determine final
22 compensation must contain twelve (12) months of service credit. If the
23 member does not have three (3) complete fiscal years that each contain twelve
24 (12) months of service credit, then one (1) or more additional fiscal years,
25 which may contain less than twelve (12) months of service credit, shall be
26 added until the number of months in the final compensation calculation is at
27 least thirty-six (36) months;

- 1 (15) "Final rate of pay" means the actual rate upon which earnings of an employee were
2 calculated during the twelve (12) month period immediately preceding the
3 member's effective retirement date, and shall include employee contributions picked
4 up after August 1, 1982, pursuant to KRS 78.610(4). The rate shall be certified to
5 the system by the employer and the following equivalents shall be used to convert
6 the rate to an annual rate: two thousand eighty (2,080) hours for eight (8) hour
7 workdays, one thousand nine hundred fifty (1,950) hours for seven and one-half
8 (7.5) hour workdays, two hundred sixty (260) days, fifty-two (52) weeks, twelve
9 (12) months, one (1) year;
- 10 (16) "Retirement allowance" means the retirement payments to which a member is

16 adjustment option as provided for in KRS 61.635(8), in which case the member's
17 actual age shall be used. For members who begin participating in the system prior to
18 January 1, 2014, no disability retirement option shall be less than the same option
19 computed under early retirement;
- 20 (18) "Normal retirement date", unless otherwise provided in KRS 78.510 to 78.852,

- 24 (b) For a member with service in a hazardous position who begins participating
25 before September 1, 2008, the first day of the month following a member's
26 fifty-fifth birthday; or

1 on or after September 1, 2008, the first day of the month following a member's
2 sixtieth birthday;

3 (19) "Fiscal year" of the system means the twelve (12) months from July 1 through the
4 following June 30, which shall also be the plan year. The "fiscal year" shall be the
5 limitation year used to determine contribution and benefits limits as set out in 26
6 U.S.C. sec. 415;

7 (20) "Agency reporting official" means the person designated by the participating
8 employer who shall be responsible for forwarding all employer and employee
9 contributions and a record of the contributions to the system and for performing
10 other administrative duties pursuant to the provisions of KRS 78.510 to 78.852;

11 (21) "Regular full-time positions," as used in subsection (6) of this section, shall mean
12 all positions that average one hundred (100) or more hours per month, determined
13 by using the number of hours actually worked in a calendar or fiscal year, or eighty
14 (80) or more hours per month in the case of noncertified employees of school
15 boards, determined by using the number of hours actually worked in a calendar or
16 school year, unless otherwise specified, except:

17 (a) Seasonal positions, which although temporary in duration, are positions which
18 coincide in duration with a particular season or seasons of the year and that
19 may recur regularly from year to year, in which case the period of time shall
20 not exceed nine (9) months, except for employees of school boards, in which
21 case the period of time shall not exceed six (6) months;

22 (b) Emergency positions that are positions that do not exceed thirty (30) working
23 days and are nonrenewable;

24 (c) Temporary positions that are positions of employment with a participating
25 agency for a period of time not to exceed twelve (12) months and not
26 renewable;

27 (d) Probationary positions which are positions of employment with a participating

1 employer that do not exceed twelve (12) months and that are used uniformly
2 by the participating agency on new employees who would otherwise be
3 eligible for participation in the system. Probationary positions shall not be
4 renewable by the participating employer for the same employee, unless the
5 employee has not been employed with the participating employer for a period
6 of at least twelve (12) months; or

7 (e) Part-time positions that are positions that may be permanent in duration, but
8 that require less than a calendar or fiscal year average of one hundred (100)
9 hours of work per month, determined by using the number of months actually
10 worked within a calendar or fiscal year, in the performance of duty, except in
11 case of noncertified employees of school boards, the school term average shall
12 be eighty (80) hours of work per month, determined by using the number of
13 months actually worked in a calendar or school year, in the performance of
14 duty;

15 (22) "Alternate participation plan" means a method of participation in the system as
16 provided for by KRS 78.530(3);

17 (23) "Retired member" means any former member receiving a retirement allowance or
18 any former member who has on file at the retirement office the necessary
19 documents for retirement benefits and is no longer contributing to the system;

20 (24) "Current rate of pay" means the member's actual hourly, daily, weekly, biweekly,
21 monthly, or yearly rate of pay converted to an annual rate as defined in final rate of
22 pay. The rate shall be certified by the employer;

23 (25) "Beneficiary" means the person, persons, estate, trust, or trustee designated by the
24 member in accordance with KRS 61.542 or 61.705 to receive any available benefits
25 in the event of the member's death. As used in KRS 78.5536, beneficiary shall not
26 mean an estate, trust, or trustee;

27 (26) "Recipient" means the retired member, the person or persons designated as

1 beneficiary by the member and drawing a retirement allowance as a result of the
2 member's death, or a dependent child drawing a retirement allowance. An alternate
3 payee of a qualified domestic relations order shall not be considered a recipient,
4 except for purposes of KRS 61.623;

5 (27) "Person" means a natural person;

6 (28) "School term or year" means the twelve (12) months from July 1 through the
7 following June 30;

8 (29) "Retirement office" means the Kentucky Public Pensions Authority office building
9 in Frankfort, unless otherwise designated by the Kentucky Public Pensions
10 Authority;

11 (30) "Vested" for purposes of determining eligibility for purchasing service credit under
12 KRS 61.552 means the employee has at least forty-eight (48) months of service if
13 age sixty-five (65) or older or at least sixty (60) months of service if under the age
14 of sixty-five (65). For purposes of this subsection, "service" means service in the
15 systems administered by the Kentucky Retirement Systems and County Employees
16 Retirement System;

17 (31) "Participating" means an employee is currently earning service credit in the system
18 as provided in KRS 78.615;

19 (32) "Month" means a calendar month;

20 (33) "Membership date" means the date upon which the member began participating in
21 the system as provided in KRS 78.615;

22 (34) "Participant" means a member, as defined by subsection (8) of this section, or a
23 retired member, as defined by subsection (23) of this section;

24 (35) "Qualified domestic relations order" means any judgment, decree, or order,
25 including approval of a property settlement agreement, that:

26 (a) Is issued by a court or administrative agency; and

27 (b) Relates to the provision of child support, alimony payments, or marital

1 property rights to an alternate payee;

2 (36) "Alternate payee" means a spouse, former spouse, child, or other dependent of a
3 participant, who is designated to be paid retirement benefits in a qualified domestic
4 relations order;

5 (37) "Accumulated employer credit" means the employer pay credit deposited to the
6 member's account and interest credited on such amounts as provided by KRS
7 78.5512 and 78.5516;

8 (38) "Accumulated account balance" means:

9 (a) For members who began participating in the system prior to January 1, 2014,
10 the member's accumulated contributions; or

11 (b) For members who began participating in the system on or after January 1,
12 2014, in the hybrid cash balance plan as provided by KRS 78.5512 and
13 78.5516, the combined sum of the member's accumulated contributions and
14 the member's accumulated employer credit;

15 (39) "Volunteer" means an individual who:

16 (a) Freely and without pressure or coercion performs hours of service for an
17 employer participating in one (1) of the systems administered by Kentucky
18 Retirement Systems or the County Employees Retirement System without
19 receipt of compensation for services rendered, except for reimbursement of
20 actual expenses, payment of a nominal fee to offset the costs of performing
21 the voluntary services, or both; and

22 (b) If a retired member, does not become an employee, leased employee, or
23 independent contractor of the employer for which he or she is performing
24 volunteer services for a period of at least twelve (12) months following the
25 retired member's most recent retirement date;

26 (40) "Nominal fee" means compensation earned for services as a volunteer that does not
27 exceed five hundred dollars (\$500) per month. Compensation earned for services as

- 1 a volunteer from more than one (1) participating employer during a month shall be
2 aggregated to determine whether the compensation exceeds the five hundred dollars
3 (\$500) per month maximum provided by this subsection;
- 4 (41) "Nonhazardous position" means a position that does not meet the requirements of
5 KRS 78.5520 or has not been approved by the board as a hazardous position;
- 6 (42) "Hazardous position" means a position that meets the requirements of KRS 78.5520
7 and has been approved by the board as hazardous;
- 8 (43) "Level-percentage-of-payroll amortization method" means a method of determining
9 the annual amortization payment on the unfunded actuarial accrued liability as
10 expressed as a percentage of payroll over a set period of years. Under this method,
11 the percentage of payroll shall be projected to remain constant for all years
12 remaining in the set period and the unfunded actuarially accrued liability shall be
13 projected to be fully amortized at the conclusion of the set period;
- 14 (44) "Increment" means twelve (12) months of service credit which are purchased. The
15 twelve (12) months need not be consecutive. The final increment may be less than
16 twelve (12) months;
- 17 (45) "Last day of paid employment" means the last date employer and employee
18 contributions are required to be reported in accordance with KRS 16.543, 61.543, or
19 78.615 to the retirement office in order for the employee to receive current service
20 credit for the month. Last day of paid employment does not mean a date the
21 employee receives payment for accrued leave, whether by lump sum or otherwise, if
22 that date occurs twenty-four (24) or more months after previous contributions;
- 23 (46) "Objective medical evidence" means reports of examinations or treatments; medical
24 signs which are anatomical, physiological, or psychological abnormalities that can
25 be observed; psychiatric signs which are medically demonstrable phenomena
26 indicating specific abnormalities of behavior, affect, thought, memory, orientation,
27 or contact with reality; or laboratory findings which are anatomical, physiological,

1 or psychological phenomena that can be shown by medically acceptable laboratory
2 diagnostic techniques, including but not limited to chemical tests,
3 electrocardiograms, electroencephalograms, X-rays, and psychological tests;

4 (47) "Hazardous disability" as used in KRS 78.510 to 78.852 means a disability which
5 results in an employee's total incapacity to continue as an employee in a hazardous
6 position, but the employee is not necessarily deemed to be totally and permanently
7 disabled to engage in other occupations for remuneration or profit;

8 (48) "Act in line of duty" means, for purposes of members serving in a hazardous
9 position, an act occurring which was required in the performance of the principal
10 duties of the hazardous position as defined by the job description;

11 (49) "Dependent child" means a child in the womb and a natural or legally adopted child
12 of the member who has neither attained age eighteen (18) nor married or who is an
13 unmarried full-time student who has not attained age twenty-two (22). Solely in the
14 case of a member who dies as a direct result of an act in line of duty as defined in
15 this section or who dies as a result of a duty-related injury as defined in KRS
16 61.621, "dependent child" also means a naturally or legally adopted disabled child
17 of the member, regardless of the child's age, if the child has been determined to be
18 eligible for federal Social Security disability benefits or is being claimed as a
19 qualifying child for tax purposes due to the child's total and permanent disability;

20 (50) "Normal retirement age" means the age at which the member meets the
21 requirements for his or her normal retirement date as provided by subsection (18) of
22 this section;

23 (51) "Disability retirement date" means the first day of the month following the last day
24 of paid employment;

25 (52) "Monthly average pay" means:

26 (a) In the case of a member who dies as a direct result of an act in line of duty as
27 defined in KRS 16.505 or who dies as a result of a duty-related injury as

1 defined in KRS 61.621, the higher of the member's monthly final rate of pay
2 or the average monthly creditable compensation earned by the deceased
3 member during his or her last twelve (12) months of employment; or

4 (b) In the case where a member becomes totally and permanently disabled as a
5 direct result of an act in line of duty as defined in KRS 16.505 or becomes
6 disabled as a result of a duty-related injury as defined in KRS 61.621 and is
7 eligible for the benefits provided by KRS 61.621(5)(a), the higher of the
8 member's monthly final rate of pay or the average monthly creditable
9 compensation earned by the disabled member during his or her last twelve
10 (12) months of employment prior to the date the act in line of duty or duty-
11 related injury occurred;

12 (53) "Authority" means the Kentucky Public Pensions Authority as provided by KRS
13 61.505; and

14 (54) "Executive director" means the executive director of the Kentucky Public Pensions
15 Authority.

16 ➔Section 16. If any provision of this Act or its application to any person or
17 circumstance is held invalid by a court of competent jurisdiction, the invalidity does not
18 affect other provisions or applications of this section that can be given effect without the
19 invalid provision or application, and to this end the provisions of this Act are severable.

20 ➔Section 17. Pursuant to KRS 141.504(2)(b), it is the intent of the General
21 Assembly that scholarships granted to students under KRS 141.500 through 141.901 be
22 limited to counties with a population of a population of 90,000 or greater. However, if
23 education opportunity accounts are held unconstitutional or unenforceable due to the
24 provision of KRS 141.504, the court's remedy shall be to apply KRS 141.500 through
25 141.901 to all counties.

26 ➔Section 18. Due to the urgent nature of litigation and the importance of
27 establishing education opportunity accounts for Kentucky students, an emergency is

- 1 declared to exist, and Section 17 of this Act takes effect upon its passage and approval by
- 2 the Governor or upon its otherwise becoming a law.
