Discussion:

CIO - Michelle Lawrence discussed the process for Chromebooks when they are damaged and the cost. Shared information from an insurance company of coverage for the Chromebooks.

Collecting fees for damaged Chromebooks is extremely difficult. Several Thousand of dollars have not been paid. Flexible with payments until they are paid off.

Many districts across the state are going to an insurance policy. One flat fee at the beginning of the year would cover the cost of replacement.

Lower and Upper Students will not take Chromebooks home next year.

Price has gone up on the Chromebooks. Each Chromebook comes with a management license as well.

Board member Hargis Davis expressed his concerns about the cost.

Board Attorney Jake Thompson gave his thoughts that other districts are using the insurance policies and the pros of having the insurance on the Chromebooks. Jake suggest that maybe some fee should be charged to help cover the cost of damaged Chromebooks.

Board Member Becky Burgett has concerns with the fee. We cannot force people to pay them.

Board Member Hargis Davis requested this item be tabled.
