Horizon's obligations are subject to detention or prevention by sickness, inability to perform, acts of God, riots, strikes, labor difficulties, epidemics, any act of any public authority or any other cause similar or dissimilar beyond Horizon's control. In such case there shall be no claim for damages by either party to this contract.

Purchaser shall be liable for any and all damages to or theft of Horizon's equipment. Purchaser shall be liable for any and all physical harm to Horizon personnel caused by Purchaser, his guests or members of his organization, business invites or employees, etc.

Purchaser and Horizon agree that this contract is not subject to cancellation unless both Purchaser and Horizon have agreed to such a cancellation in writing. It is further agreed that any cancellation by Purchaser will result in a 20% cancellation penalty, of the agreed upon fee to be paid at time of cancellation.

The Purchaser hereby agrees that if Horizon or any agent of Horizon should be required to resort to legal action to enforce any or all of the provisions of this contract, that the cost and expense of such legal action, including reasonable attorney fees, will be assumed by the Purchaser.

By executing this contract as Purchaser or Horizon, the person executing said contract warrants that he or she is of legal age and further, if executing said contract, has the authority to enter into this agreement and personally accepts and assumes full responsibility and liability Under the terms of this contract.

This contract contains the entire agreement between the parties and shall not be enlarged, modified or altered except in writing signed by the parties and endorsed herein.

ADDITIONAL INFORMATION:

• DJ will need access to the performance area at least one hour before the event starts in order to set up equipment.

HORIZON RESERVES THE RIGHT TO CANCEL THE ENGAGEMENT IF THIS CONTRACT IS NOT RETURNED WITHIN 90 DAYS.
