HISTORY/BACKGROUND:

Kenton County Student Nutrition joined the IPS Rebates program in 2017, earning rebates on food purchased through awarded contracts. The IPS Rebate program is offering an additional \$1,000 rebate paid over three consecutive years. If an active member IPS will award Student Nutrition an additional \$300 for the 2021-2022 school year, \$300 for the 2022-2023 school year, and \$400 for the 2023-2024 school year.
