## APPLICABLE BOARD POLICY:

4.1 Budget Planning & Adoption

#### **HISTORY/BACKGROUND:**

The General Assembly continues to allow flexibility in the use of school district capital funds without forfeiting the district's eligibility to participate in the School Facilities Construction Commission (SFCC) program. The Board approved an initial 2022 Capital Outlay Fund transfer on May 2, 2022 in the amount of \$1,327,457. A amendment is now necessary to incorporate the use of \$100,000.00 of Capital Outlay Funds to the Hinsdale Construction project BG 21-142 approved by the Board on May 2, 2022. The 2022 amended transfer to the General Fund is \$1,227,457.

#### FISCAL/BUDGETARY IMPACT:

Transfer of \$1,227,457 from Capital Outlay Fund to General Fund in FY 2022
