Behaviorally Targeted Ads.

Learn21 does not permit behavioral targeting of advertisements – i.e. ads that use any behavioral information to provide targeted advertising to students. Learn21 also pledges to not collect, use, or share such information for any purposes beyond the authorized educational or school purposes, or as authorized by the student or parent.

Third Parties.

Learn21 will only share student data with third parties that are consistent with our policies. Any third party that Learn21 shares information with will have privacy practices consistent with our privacy policy. This also includes links to third parties.

Data Accessibility

Learn21 will provide access to student personal information to parents and students for review and correction whether the access is through Learn21 or through the school, teacher, or educational entity. Data Retention,
