## Issue Paper

**Consent Agenda Item (Action Item):** Consider and approve a contract with Imagine Learning for Virtual Instruction Services for the students enrolled at the Floyd County Virtual Academy (Grades K-5) for the 2022-23 School Year.

**Applicable Statue or Regulations:** KRS 162.90 Powers and Duties of the Local Board of Education – Only the local Board of Education may approve and enter into a contract.

**Fiscal/Budgetary Impact:** All expenses associated with the Floyd County Virtual Program are being paid from ESSER Funding. No financial impact to the District's General Fund.

**History/Background:** The Floyd County Board of Education will continue to provide instruction via the Floyd County Virtual Academy. The students in the Virtual Academy will be serviced via Imagine Learning for online services including instruction and assessment. The cost of the service is \$1000 per semester for students in K-5. The contract presented allows for Floyd County to reserve 50 seats per semester. If more than 50 students enroll, the cost will remain \$1000 per student per semester and Imagine Learning will bill the district quarterly. Any unused seats will carry over to the Fall semester of the 2023-24 school year. Students will receive instruction within the four core classes and Imagine Learning will also provide a workbook for the students to complete paper pencil tasks. Other features of the program include: Kentucky State Certified Teacher. Monitored course activity and attendance reporting, remediation and enrichment provided, grade activities and feedback, progress updates to students, families and staff as well as interventions provided online and on-demand tutoring for students in grades 3-5. These services in addition to the use of Floyd County facilitators and in-person tutoring as needed, should enhance the program for all students involved.

**Recommended Action:** Approve the contract for Imagine Learning to provide Virtual Instruction Services for the students enrolled at the Floyd County Virtual Academy (Grades K-5) for the 2022-23 School Year.
