BACKGROUND INFORMATION:
HB 563 (2021) Amended KRS 158.120 to require that by July 1, 2022, local Boards adopt a nonresident pupil policy to govern the terms under which the district shall allow enrollment of nonresident pupils. Non-resident contracts will no longer be necessary.  SUMMARY OF MAJOR ELEMENTS:
The Board must decide whether they will or will not allow non-resident students. Per policy 01.5, the Board may enact a policy in one emergency reading with the rationale as such reflected in the minutes as being the July 1, 2022 deadline.

### **Nonresident Students**

☐ The District shall not allow nonresident students to enroll in the District.

☐ The District shall allow nonresident students to enroll in the District pursuant to existing\*
Admissions and Attendance Policy 09.12, Tuition Policy 09.124, and related procedures.

Upon allowing nonresident pupil enrollment, the policy shall allow nonresident children to be eligible to enroll in any public school located within the District. The policy shall not discriminate between nonresident pupils, but may recognize enrollment capacity, as determined by the District. The nonresident pupil policy and any subsequent changes adopted by the Board shall be filed with the Kentucky Department of Education no later than thirty (30) days following their adoption.<sup>2</sup>

#### DEFINITIONS

Nonresident students are those students who reside outside the boundaries of the District.

#### CRITERIA FOR ENROLLMENT,

All nonresident students wishing to enroll for the coming school year shall be required to submit a tuition student or Open Enrollment application. Admission of each nonresident student must be based on the recommendation of the Superintendent or the Superintendent's designee. The following criteria shall be used in evaluating tuition student applications:

- 1. Classes or grades affected are not already filled to capacity based on state funding levels.
- Barring extenuating circumstances substantiated by a written doctor's statement, students shall not be enrolled, who have been considered truants during the previous school year.
- Unless approved by the Superintendent or the Superintendent's designee, no student shall be enrolled, who has been suspended or expelled from school during the previous or current year.
- 4. Any non-resident student who is suspended or is a truant will risk revocation of tuition status the next academic year.
- 5. Payment of tuition at the beginning of each quarter.

#### **EMPLOYEES' CHILDREN**

Children of District employees may attend tuition free without regard to residence.<sup>1</sup>
