Planned number of searches is 375 searches. A scheduled search can only be altered if called to an emergency at another JCPS site. Emergency calls supersede a regular search. After being notified of a bomb threat, response will be made in less than 30 minutes for search. Narcotics dogs have been trained on 4 real drug odors from an independent certified K-9 trainer. Explosive and firearms dog has been trained on 9 real explosive odors and firearms from an independent certified K-9 trainer. Dogs are trained as passive response dogs. * ATF application sent in 3/18/2022. In person visit from ATF will be on 5/25/22 for license approval. *Liability Insurance Policy- quote is attached. Policy will be purchased upon acceptance of bid. *Unique Entity Identifier (SAM)- Online request was made on 5/16/2022, pending approval from federal government. *Attachments include: W9, DEA license, Rabies certificates, Dog Certifications, KY State Permit for Explosives, School Recommendation Letters, Liability Insurance Quote, Vendor Reference Form, Reciprocal Preference form, and JCPS Fillable Submittals.
