## **IV. Work Sessions**

## A. Work Session: Summer Learning Opportunities

Dr. Pollio and his team presented a report on summer learning initiatives for students in Pre-Kindergarten through Grade 12. Each Board member had an opportunity to comment and ask questions. Board members expressed appreciation for the work going into the programs.

Ms. McIntosh asked if/how schools would provide feedback to parents regarding student progress. She encouraged the District to continue building community partnerships.

Mrs. Duncan asked who would be attending the camps and how they ensure that the right students were targeted.

Mr. Craig was interested in hearing more about funding, enrollment, and accountability numbers.

Chair Porter questioned accountability, specifically with the Ready 4K camps; and funding for future summer learning programs.

#### B. Work Session: Pathfinder School of Innovation

Dr. Pollio and his team shared information regarding the implementation of a virtual school during the 2021-2022 school year. Each Board member had an opportunity to comment and ask questions.

Ms. McIntosh asked how the District is making sure that students in Pathfinder are accessing wraparound services. She also questioned opportunities for extracurricular opportunities

Dr. Shull questioned Pathfinder for students in the alternative school population and wanted to hear more information on how virtual school is working for them.

Mr. Marshall questioned staffing options and the possibility of virtual employees.

Mrs. Duncan questioned the number of students moving in and moving out of the virtual school and what mental health supports were available.

Mr. Craig wanted to understand why families are choosing Pathfinder for elementary students. He expressed discomfort and questioned how they arrived at the 80 percent coursework and 80 percent attendance number. He expressed concern about elementary students not being in the school building and concluded, "I'll support it and vote yes for it tonight but I don't want to see it next year and I would actively oppose it next year."

Chair Porter suggested the District collect follow-up data from the parents regarding concerns so maybe they can offer another alternative in the future.
