THIS AGREEMENT is made and entered into this(date), by and between Education for the Extraordinary Inc., 12993 Frogtown Connector Road, Walton, KY 41094 (hereinafter referred to as "Separate School"), and the Gallatin County Board of Education, 75 Boardwalk Warsaw, KY 41095, (hereinafter referred to as "Public School").

In consideration of the mutual promises, agreements and undertakings hereinafter set forth, it is hereby agreed as follows:

1. The Separate School will provide service in the categories of: academic instruction, student IEP planning and implementation, Occupational Therapy, Speech Therapy, and Applied Behavior Analysis therapy.
2. The services will be provided on days students are in session according to the Separate School Academic Calendar. Hours for those days are as follows: Mondays 9:30-1:30, Tuesdays-Fridays 8:30-3:30.
3. The Public School shall pay the Separate School for services rendered pursuant to this Agreement at the rate of 49,000 per academic year (\$4,900 a month) plus \$75 per hour for related services (Occupational Therapy, Physical Therapy, Speech). The Separate School will maintain accurate records and documents for the computation of all charges.
4. The Separate School will invoice Public School for education services performed pursuant to this Agreement at the beginning of the month following the month the services were performed. Invoice will be paid by no later than the fifteenth (15<sup>th</sup>) day of the month following the month such services were performed. A rate of \$4,900 a month per student will be billed for as long as the student is in attendance and until the student has transitioned back to Public School full time.
5. The Separate School will invoice Public School for related services performed pursuant to this Agreement at the beginning of the month following the month the services were performed. Invoice will be paid by no later than the fifteenth (15<sup>th</sup>) day of the month following the month such services were performed.
6. The Public School will provide transportation both to and from the Separate School on all in session days according to the Separate School Academic Calendar.
7. All services provided to student(s) will be in accordance with an individual education program (IEP).
8. The Public School shall make available all records and information relevant to the student for the purpose of the services being provided. The Separate School shall maintain records and reports in accordance with the policies of the Public School.
9. The Public School will be responsible for any state mandated testing required by the Kentucky Department of Education.
10. The Public School shall provide reevaluations every 3 years to serve students under the scope of this Agreement.
11. The Separate School will maintain insurance against liability for injury or death of any person growing out of the performance of professional duties. Evidence of such insurance will be made available to the Public School on request.

12. It is agreed by both parties to this agreement that they shall be in compliance with all existing Federal, State and local laws and regulations, specifically IDEA law.

13. This Agreement shall continue and be binding upon the parties hereto until (date) unless terminated as herein provided. This Agreement may be amended by written consent of both parties and all amendments shall be attached to this Agreement and made a part thereof.
