LIBRARY BOARD APPOINTMENTS

RESOLUTION NO. 2022-32

A Resolution approving the alternative appointment process regarding Ohio County Library District Board member appointments;

WHEREAS, the Ohio County Library District is established within Ohio County, Kentucky; and

WHEREAS, the 2022 Kentucky General Assembly amended parts of KRS Chapter 173 so as to create and permit a Library District board member alternative appointment process; and

WHEREAS, the alternative appointment process may be implemented by approval and passage of a resolution by the Ohio Fiscal Court; and

NOW THEREFORE, BE IT RESOLVED by the Ohio County Fiscal Court, Commonwealth of Kentucky as follows:

The Ohio County Fiscal Court finds and adopts an alternative appointment process as noted in KRS 173.490 as it relates to Ohio County Library District Board member appointments. Specifically as noted in said statute, the Ohio County Judge Executive:

- (A) 1. May immediately, with the approval of the fiscal court, make the selection of the Library Board appointments from those recommended by the Department for Libraries and Archives; and
- 2. For any appointments the Ohio County Judge Executive decides not to fill from the first recommendations, shall request the Department for Libraries and Archives to submit within (30) days two (2) additional recommended persons for each unfilled appointment, and, with the approval of the fiscal court, may make the selection from those recommendations; and

(B) For any remaining unfilled appointments after the provisions of paragraph (A) of this subsection have been followed, shall appoint, with the approval of the fiscal court, individuals of his or her choosing, whether or not the individuals signed the petition, no later than thirty (30) days after the day the county judge/executive received the recommendations under paragraph A(2) of this Resolution and made no appointment therefrom. The Ohio County Judge Executive shall notify the Department for Libraries and Archives of the name(s) of any individual appointed in the manner set out in this paragraph.

The alternative process shall also be used should a board member need to be appointed, resigns, a vacancy occurs or no longer serves during his or her time of appointment.

Upon motion duly made and unanimously carried, the same was adjourned.

Please see attached bid for services for FYE 6/30/23. As I am sure with all your other service bids, we are experiencing a significant cost increase in everything from payroll, to fuel to medical supplies.

As you can see, this is a projected increase of \$78,000, We anticipate no increase in Medicaid or Private Insurance revenue and possibly a 3% Medicare increase which will be approximately a \$14,800 increase over the next 12 months.

We currently, and have always operated Ohio County EMS on a thin margin. The inflationary changes we are seeing will put Ohio County EMS in a negative cash position within the next 12 months unless we raise our subsidy more than you have normally seen. You are not alone in this issue. Simpson County EMS, a similar sized service is government operated and spending in excess of \$600,000 annually to operate their service. They underwent an RFP process in 2021 to subcontract to a private provider and their lowest bid was \$950,000.

This is not a place we want to be, but unfortunately this is where we are at. We will always provide quality, patient centered services for the citizens of Ohio County as long as we possibly can.

Proposal for EMS Service Management

- Com-Care Inc., A locally owned and operated company, hereinafter referred to as " Com-Care " proposes to provide to the Ohio County Fiscal Court the following services related to the operation of the Ohio County Emergency Medical Services.
- Com-Care will operate an Advanced Life Support, Class 1 ground ambulance service as set forth in KRS 311.030 and 202 KAR Chapter 5. The period of this proposal will be from 7/1/22 thru 6/30/23. A base will be maintained at the location of the current EMS building located in Hartford and owned by the Ohio County fiscal court. Com-Care will staff 24 hour ALS coverage plus additional day shift crews as needed for non-emergency transfers. Additional on-call staff will be scheduled daily to address periods of increased run volume. Com-Care will secure and provide an additional base in the Fordsville area. Com-Care will provide utilities for the Fordsville Station..
- Com-Care Inc. is a subchapter "S" Corporation owned by James Duke (52%) Marcus Barnett (24%) and Cynthia Adams (24%).
- Com-Care will furnish materials, supplies, storage, and any other items necessary or convenient to the operation of a complete emergency and non-

Cynthia Adams Vice President - Finance emergency Ambulance Service for Ohio County, Kentucky, except as hereinafter provided.

- Com-Care will provide all vehicle maintenance to ambulances provided by the fiscal court and will maintain said vehicles in good operational order.
- Com-Care will act as an agent for the county to secure grant funding from state and federal sources as related to Emergency Medical Services. Any equipment or funds secured would be the sole property of the Ohio County Fiscal Court and will be maintained for a period of no less than 7 years. From 2009 until present, Com-Care has secured through Homeland Security and the Hospital preparedness partnership approximately \$200,000 in emergency response supplies.
- Com-Care shall be in complete and total control of the management of said Ambulance Service, will have complete and unlimited discretion in the hiring, discharge, payment, and assignment of duties of the employees and personnel of the Ambulance Service; and in the billing and collection of fees and charges generated by such Ambulance Service. All billings and receipts for services which occur during the period contractually agreed upon by both parties shall be the property of Com-Care.
- Com-Care will provide professional liability insurance in the amount of no less than 3 million dollars (\$3,000,000.00), in addition to a 5 million dollar (\$5,000,000) Umbrella Policy.
- Com-Care will maintain all run records as required through 202 KAR Chapter 7 during the period of any contractual agreement and provide all stored run data to the Ohio County Fiscal Court whenever any agreement terminates.
- Com-Care will provide the fiscal court any data related to run volume, response times and demographic information as requested.
- Com-Care will implement a plan with the local EMT's, Firefighter's, Law Enforcement and First Responders for consumable supply replenishment at no cost to the responding agencies. Monthly training will be provided in the county for all First Responders.
- Any proposal and/or subsequent contract will have an exemption clause for operations during a National, State or locally declared disaster. It will be necessary to remount Med 6 in the upcoming FY at an approximate cost of \$95,000.
- Use of up to One (1) Ohio County Ambulance to use during Disaster deployments within the region. Use would not exceed 28 days under this proposal per year.
- 6) An annual subsidy of \$174,996 payable in 12 equal monthly payments of \$14,583.00 being paid at the beginning of each month. The amount will not include any needed ambulance vehicles or large capital equipment which would remain sole property of Ohio County Fiscal Court.
