On behalf of the 27-member board of directors and staff of your Kentucky School Boards Association, we are grateful for your board team's continued engagement in association training, advocacy efforts, and district services. As you know, KSBA is the only organization working directly on behalf of Kentucky's 857 school board members, and we stand poised once again to lead the charge in the new school year.

KSBA's longstanding priorities of *member ownership, advocacy, service delivery,* and *partnerships* serve as the foundation of our annual strategic planning, and this past year's objectives represented some of our most ambitious to date. Such vision resulted in major milestones, just a few of which included:

- KSBA offered *more* training opportunities on *more* subjects incorporating *more* formats than ever before, ensuring members could efficiently obtain state-mandated training while selecting topics of local relevance. That resulted in members earning nearly 1,000 more training hours than the previous year.
- KSBA's experienced staff provided districts with ongoing legislative, legal, policy, and procedural guidance, equipping boards with resources for good governance. Whether through special webinars, video updates, or FAQs, KSBA found new ways of offering the information you need from experts you trust.
- KSBA tracked more than 400 education-related bills during two legislative sessions, providing substantive feedback to lawmakers and carefully contributing to bill draft language.
- KSBA communications reached more education stakeholders than ever, leading the conversation on how to move Kentucky public education forward. As our audiences grew, so did our influence.

We pride ourselves on the fact that 100 percent of locally elected school boards are active members and that our annual membership dues remain well below the national average for professional associations.

Together we can accomplish great things for Kentucky's public school board members, districts, students, and communities. We ask that you renew your membership for the new fiscal year. The 2022-23 dues schedule was unanimously approved by KSBA's board of directors on June 18. Your district's dues for the new fiscal year are \$7,119.49 . A copy of the invoice is enclosed.

KSBA strives to maximize the value of membership for Kentucky's 857 school board members and the districts they serve. The results? Expanded training opportunities. Effective advocacy. Relevant news and updates. Superior service you can rely on from the experts you trust. Better boards mean better public schools.

KSBA continues to enhance the means by which school board members earn state-mandated training. Members earned nearly 1,000 more hours in 2021 than the previous year. How? We offered more training opportunities on more topics in more formats than ever before. 85 percent of members exceeded the minimum requirements set by the state. It's no surprise that local school board members love to learn how to better serve their communities.





KSBA tracked 402 bills in 2021-22 with possible implications for district operations, recommending bill draft language to lawmakers and providing substantive feedback on behalf of school boards. KSBA prepared 7,162 individual model policy and procedural changes for the 170 school districts that subscribe to our Policy Service. That critical staff expertise is available to members year round, not just when the legislature is in session.

KSBA compiles important information and distills it down to what is most pertinent to board teams, from ongoing legislative coverage to features on innovations at the district level. In 2021-22, members received 10 issues of our magazine, more than 50 electronic publications, dozens of videos and countless resources available on the association's website. Our social media content was viewed more than 3.75 million times. We are not just contributing to the conversation on education, we are leading it.
