## **ACTION ITEMS**

#### 1) CONSIDERATION FOR APPROVAL – MAY MEETING MINUTES

The minutes of the May 3, 2022 meeting were recommended for approval.

A motion to approve was made by Tim Grove; seconded by Chris Conley; motion approved 18-0.

#### 2) PROPOSED EMERGENCY AMENDMENT TO IHSAA BY-LAW 10-1, OUT-OF-STATE CONTEST LIMITATIONS

Commissioner Paul Neidig and General Counsel Katie Williams-Briles presented the following updated language after the original proposal had been tabled at last month's meeting.

# RULE 10 – INTERSTATE CONTESTS AND PRACTICES REQUIRING SPECIAL ATTENTION

**10-1 Out of State Contest Limitations** 

Page 49

## 10-1.1 Out-of-State Contest Limitations

The address of out-of-state schools participating in a Contest against a Member School as well as the site of such Contests must be within Six-hundred (600) miles round trip travel is from the Indiana state line and shall be sponsored or co-sponsored by a Member high School.

Member Schools may only participate in an out-of-state Contest if:

- a. the site or venue of a Contest is within (300) miles from the Indiana State line;
- b. the Contest is against a school that is a member of a state athletic association; and
- c. the event is sanctioned as needed by the IHSAA through the NFHS sanctioning process. (rule 10-1.3).

#### **10-1.2 In-State Contest Limitations**

Out-of-state schools who participate against an IHSAA Member School in a Contest in Indiana must:

a. be a member of their state's athletic association;

- b. be in "good standing" with their state's athletic association; and
- c. the event be sanctioned as needed by the IHSAA through the NFHS sanctioning process. (rule 10-1.3).

A motion to approve was made by Dave Worland; seconded by Chris Conley; motion approved 15-2-1 with Stacy Adams and Mike Whitten opposed and Jeff Doyle abstaining.

# 3) PROPOSED EMERGENCY AMENDMENT TO IHSAA BY-LAW 19-5.1, TRANSFER OPTIONS WHEN TRANSFER WITH CHANGE OF RESIDENCE BY PARENT(S)/GUARDIAN(S)

Commissioner Paul Neidig and General Counsel Katie Williams-Briles presented the following updated language from last month's meeting.

# 19-5.1 TRANSFER OPTIONS WHEN TRANSFER WITH CHANGE OF RESIDENCE BY PARENT(S)/GUARDIAN(S) 19-5.1 Transfer Options When Transfer with Change of Residence by Parent(s)/Guardian(s) Page 94

When a student's parents(s)/Guardian(s) make a Bona Fide change of residence to a New District or Territory, the student has the following options:

\* \* \* \*

c. the student may transfer and attempt to obtain Limited Eligibility full eligibility in any Public, Private, or Private School, or Charter School which does not serve the student's area of residence is located within a Twenty (20) mile radius of the new residence of the Parent(s)/Guardian(s) when the Bona Fide change of residence involved a move of more than Seventy-five (75) miles; or and is the student's first time enrolling in an Indiana school; or

## 4) FULL MEMBERSHIP FOR EVANSVILLE CHRISTIAN HIGH SCHOOL

Assistant Commissioner Chris Kaufman reported on Evansville Christian as a provisional member during the last four years and recommended full membership approval. The school is now eligible for state tournament participation beginning with the 2022-23 school year.

A motion to approve was made by Patti McCormack; seconded by John Steinhilber; motion approved 17-1 with Chad Gilbert opposed.

# 5) FULL MEMBERSHIP FOR PURDUE POLYTECHNIC HIGH SCHOOL

Assistant Commissioner Chris Kaufman reported on Purdue Polytechnic as a provisional member during the last three years and recommended full membership approval. With the recent by-law modification that reduces the provisional member school waiting period from four years to three years, the school is now eligible for state tournament participation beginning with the 2022-23 school year.

A motion to approve was made by Dave Worland; seconded by Tim Grove; motion approved 16-1 with Chad Gilbert opposed.

# 6) FULL MEMBERSHIP FOR MTI SCHOOL OF KNOWLEDGE HIGH SCHOOL

Assistant Commissioner Robert Faulkens reported on MTI School of Knowledge as a provisional member during the last three years. With the recent by-law modification that reduces the provisional member school waiting period from four years to three years, full membership was considered. Mr. Faulkens reported that the school's participation numbers are growing but did not recommend full membership approval for the school at this time. Full membership for the school will be reviewed again in one year.

A motion to approve of Mr. Faulkens recommendation against full membership for the school was made by Mike Whitten; seconded by Chad Gilbert; motion approved 17-0.

## 7) FULL MEMBERSHIP FOR DUGGER UNION HIGH SCHOOL

Assistant Commissioner Sandra Walter reported on Dugger Union High School as a provisional member during the last four years and recommended full membership approval. The school is now eligible for state tournament participation beginning with the 2022-23 school year.

A motion to approve was made by Chris Conley; seconded by Jim Brown; motion approved 15-2 with Ed Gilliland and Chad Gilbert opposed.

# 8) CHANGES TO IHSAA POLICY MANUAL

Commissioner Paul Neidig and General Counsel Katie Williams-Briles reported on the updates to the IHSAA Policy Manual.

#### **Tournament Admissions**

The Executive Committee reviewed the suggested admission price changes at the various levels of each state tournament.

Admission to the Girls and Boys Golf State Finals was amended to increase from \$12 to \$15.

A motion to approve that amendment was made by Tim Grove; seconded by John Steinhilber; motion approved 16-1 with Chris Conley opposed.

Admission to the Boys and Girls Tennis regionals, semi-states and state finals was amended to increase from \$5 to \$7. A motion to approve that amendment was made by Ed Gilliland; seconded by Tom Black; motion approved 15-1 with Mike Whitten opposed.

A motion to approve the adoption of the Tournament Series Admission Policy was made by Kye Denney; seconded by Stacy Adams; motion approved 17-0.

# **Tournament Director Stipends**

The Executive Committee reviewed the suggested changes to the Tournament Director Stipend Policy.

A motion to approve the adoption of the Tournament Director Stipends Policy was made by Mike Whitten; seconded by Kye Denney; motion approved 16-1 with John Steinhilber opposed.

# **Tournament Officials Mileage and Stipends**

The Executive Committee reviewed the suggested changes to the Tournament Officials Mileage and Stipends Policy which included a \$10 raise at all levels and an increase in mileage from 25 cents to 50 cents per mile.

A motion to approve the adoption of the Tournament Officials Mileage and Stipend Policy was made by Tim Grove; seconded by Chad Gilbert; motion approved 17-0.

#### **State Medals Distribution**

The Executive Committee reviewed the suggested changes to the State Medals Distribution Policy.

A motion to approve the adoption of the State Medals Distribution Policy was made by John Steinhilber; seconded by Kye Denney; motion approved 16-1 with Victor Bush opposed.

# 9) GRANTING THE HONORARY EMERITUS TITLE TO FORMER COMMISSIONER BOBBY COX

Commissioner Paul Neidig requested that the honorary title "Emeritus" be granted to retired IHSAA Commissioner Bobby Cox who served the Association for 20 years including nine as commissioner (2011-20).

A motion to approve was made by Ed Gilliland; seconded by Jim Brown; motion approved 17-0.

#### **REPORTS**

#### 10) CHANGE TO THE BOYS & GIRLS BASKETBALL TOURNAMENT FORMAT

Assistant Commissioner Brian Lewis presented a proposal that would change the format of the IHSAA Boys and Girls Basketball State Tournaments by switching the regional and semi-state formats. The regional would become a one-game championship on Saturday with the semi-state round a two-game format the following Saturday. This would be effective with next winter's tournaments )2022-23 school year). The previous format of a two-round regional and a single semi-state game had been in place since 2002.

Regional pairings will be drawn and announced at the same time as the traditional sectional pairings with two regional championship games being played at the same site and potentially from different classes. Another new wrinkle includes conducting an additional blind draw and announcing the semi-state pairings the day after the regional championship games on IHSAAtv.org.

This spring, Commissioner Paul Neidig conducted a survey of principals, athletic directors, boys and girls coaches and 73.4% of those 781 respondents voted in favor of changing the format with at least 70% in all four groups approving. Those results are below:

# **28) OFFICIALS REPORT**

Assistant Commissioner Sandra Walter issued a list of licensed IHSAA Officials by sport and by year along with the percentage of license renewals. The good news is every sport had a renewal rate of more than 100% for the 2022-23 school year.

She reported that 34 member schools and two universities will offer the course, Sports Officiating 101, this fall. There are 681 students who have registered for the class.

She had presented at the National Federation's Officials Consortium in recent weeks and many states expressed great interest in what Indiana is doing. She will also present to attendees at next week's NFHS Summer Meeting.

Director of Technology Luke Morehead presented a recap of 2021-22 technology projects and previewed projects planned for 2022-23.

#### 30) IHSAA FOUNDATION QUARTERLY REPORT

Foundation President Matt Wolfert reported on the following items:

- 1. Reviewed 5-Year IHSAA Foundation growth chart as estimated for the fiscal year ending 6/30/22. Total giving this year is \$304,698, up 52% year-over-year, and 227% over 5 years. Total donors this year is 975, up 20% year-over-year, and 719% over 5 years.
- 2. Reviewed 2022 scholarship winners list. The IHSAA Foundation gave out 23 scholarships worth \$41,000. Cato (12), General (8), Unified/Champions Together (3).
- 3. 30 member schools have received a \$1,000 grant for the development of a Student Advisory Committee during 2022-23. The list will be found on the website.
- 4. Reviewed the plan for the ISOI Expedition for 2022-23. Grants will be distributed for member schools to participate.
- 5. Reviewed the Annual Funding Initiatives for 2022-23. The estimated goal is \$100,000. The 4 Funding Pillars are:
  - a. Member-school grants for SAC Development, SLC Attendance, and InSideOut Initiative implementation.
  - b. Post-Secondary Scholarships
  - c. AD Leadership Development
  - d. IHSAA Officials Leadership Development, Recruitment, and Retention (including IHSOLA partnership, and member-school elective class on officiating.
- 6. The 7<sup>th</sup> Annual IHSAA Foundation Golf Outing is set for July 29<sup>th</sup>. The event is sold out for teams, but if member schools are interested in a hole sign sponsorship, please contact the office.
- 7. Thank you for your support and advocacy of the work the IHSAA Foundation is doing.

Attorney Katie Williams-Briles updated the Executive Committee on the status of pending litigation against the Association as well as results from the Case Review Panel at the Indiana Department of Education.

## **32) PENALTIES ASSESSED**

Bethesda Christian HS – Baseball - Rule 4-1 (A student-athlete participated in multiple interscholastic contests and will turn 20 before the scheduled date of the baseball state finals)

- 1. The Bethesda Christian baseball program is issued a warning. This warning is official notice a member school By-Law violation has occurred and shall not be repeated.
- 2. The student-athlete involved in this violation is declared ineligible for the remainder of her high school career.
- 3. The contest(s) in which the ineligible student-athlete participated in shall be forfeited if Bethesda Christian was victorious. The opposing school(s) shall be notified of this violation.
- 4. Part of an IHSAA member school's obligation is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Eastern Hancock HS – Girls Tennis – Rule 19-7 (Two student-athletes participated in multiple matches with an approved foreign exchange student transfer on file)

1. The Eastern Hancock High School Girls tennis program is issued a warning. This warning is official notice that a member school By-Law violation has occurred, is a matter of record, and shall not be repeated.

- 2. The student-athletes are declared ineligible until a completed transfer report is submitted and ruled upon.
- 3. In accordance with Rule 3-9, the contest(s) in which the ineligible student-athlete participated shall be rescored to remove any team points earned by the ineligible student-athletes and the opposing school(s) shall be notified of this violation.
- 4. Part of an IHSAA member school's obligation is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Jac-Cen-Del HS – Boys track & field – Rule 19-3 (A student-athlete participated in multiple meets without an approved transfer on file)

- 1. The Jac-Cen-Del boys track & field program is issued a warning. This warning is official notice that a member school By-Law violation act has occurred, is a matter of record, and shall not be repeated.
- 2. The student-athlete is declared ineligible until a completed transfer report is submitted and ruled upon.
- 3. In accordance with Rule 3-9, the contest(s) in which the ineligible student-athlete participated shall be rescored to remove any points earned by the ineligible student-athlete and the opposing school(s) shall be notified of this violation.
- 4. Part of an IHSAA member school's obligation is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Knox HS – Boys Basketball - Rule 15-2.1(b) (Assistant basketball coach participated in a contest with current student-athletes during the school year out of season and outside of the limited contact period.)

- 1. The Knox boys basketball program is issued a warning. This warning is notice that an IHSAA member school rule violation has occurred and shall not be repeated.
- 2. Assistant Coach Nick Czarnecki is reprimanded for allowing this violation to occur. Unfamiliarity of the rules is not an acceptable rationale for violating IHSAA member school By-Laws. Further member school By-Law violations may result in the boys basketball program being placed on probation.
- 3. Part of an IHSAA member school's obligation is to uphold the member school By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Northridge HS – Baseball - Rule 51-4 (A student-athlete was not given the proper days of rest after pitching in a contest)

- 1. The Northridge baseball program is placed on probation for this student-athlete health and safety IHSAA By-Law violation for 365 days from the date of this occurrence. This communication serves as official notice that serious violation has occurred, is a matter of record and future, similar incidents will not be tolerated.
- 2. Head Coach Chad Gerard is reprimanded for allowing this student-athlete to exceed the maximum pitch count, therefore, allowing this health and safety violation to occur.
- 3. If victorious Northridge High School shall forfeit, the interscholastic contest in which this student athlete participated in. The opposing school shall be notified of this forfeiture.
- 4. Part of an IHSAA member school's obligation is to uphold the By-Laws of its association and furthermore to self-report any violation to the Commissioner (Rule 3).

Tippecanoe Valley HS – Boys Basketball - Rule 15-2.1(b) (Head basketball coach held a limited contact session during the school year out of season and outside of the limited contact period.)

- 1. The Tippecanoe boys basketball program is issued a warning. This warning is notice that an IHSAA member school rule violation has occurred and shall not be repeated.
- 2. Head Coach Joe Luce is reprimanded for allowing this violation to occur. Unfamiliarity of the rules is not an acceptable rationale for violating IHSAA member school By-Laws. Further member school By-Law violations may result in the boys basketball program being placed on probation.
- 3. The fall limited contact sessions (Week 9 Sat. Week 18/max 16) are reduced by one (1) during the limited contact period.
