

Addendum to State Agency – School Food Authority Agreement
Fresh Fruit and Vegetable Program

This agreement is between the Division of School and Community Nutrition (State Agency) and the Jefferson County Board of Education (School Food Authority (SFA)).

The undersigned has the authority to enter this Agreement to participate in the Fresh Fruit and Vegetable Program (Program) (FFVP) as authorized by Section 4304 of Public Law 110-234, the Food, Conservation, and Energy Act of 2008.

A. It is mutually agreed between the State Agency and School Food Authority that:

1. The School Food Authority agrees that the funds will only be used for the purposes authorized by Section 4304 of the Food, Conservation, and Energy Act of 2008, (Public Law 110-234).
2. The School Food Authority agrees to abide by all of the requirements for administering the Program as stated in Section 4304 of the Food, Conservation, and Energy Act of 2008 (Public Law 110-234).
3. The School Food Authority agrees to provide funds to the School Food Authority's approved FFVP sites under its jurisdiction for the service of approved fresh fruits and vegetables in accordance with local, State, and Federal regulations and requirements.

B. General Conditions

1. This Agreement is non-transferable.
2. Neither the State Agency nor the School Food Authority has an obligation to renew this agreement.
