Missing Children

35 of our students have been reported missing to the Kentucky State Police this school year alone. Based on IC notification review only, we are believed to have more missing children per year than any other school district in KY. A formal request is submitted to KDE for confirmation.

This does not account for our students that are whereabouts unknown.

We continue to have 1 missing child and are thankful for the return of a student after 1 year of having no known whereabouts as an unaccompanied minor.

Resiliency Survey- Summary Results

2021-2022 Initial year for Resiliency Survey- benchmark year

Grades 3-12 - Newport Intermediate, Newport High, Newport School of Innovation 42% of our students reported overall resilience in the positive end of the continuum with an 11% increase from fall 2021.

Students reporting high levels of anxiety did not change from the Fall semester, 2021; levels of depression differed depending on grade level


"Youth who do not possess strengths and/or who report high distress are more likely to experience poor academic, interpersonal, and social outcomes. These outcomes include (a) dropping out of school, (b) expressing high psychological distress, and (c) reporting high interpersonal distress, which may include experiencing peer victimization and ostracism. Without intervention, many of these students will continue to display poor functioning as adults."

Students who possess key strengths and who lack significant distress display optimal academic, interpersonal, and psychological functioning-both now and later as adults.

At Risk- few or no strengths and high distress- Will require attention and support. Functioning likely to be affected even if not discernible.

Moderate Concern- Some strengths but poor functioning in key domains- may require some attention- Likely some impact on life and school functioning.

Spring 2022 58% of students identified as at -risk or having moderate concern. Only 6% were in the optimal range. 69% of students identified in the same areas in the fall of 2021.


How Often Did You Feel: Hopeless

Percent that answered 'Most of the time' or 'All of the time'



Percent that answered 'Most of the time' or 'All of the time'



Percent that answered Yes





Percent that answered at least 1 time









Actions

- Completed 2021-2022 Time & Effort for School Counselors Districtwide
- Continue PLC for School Counselors monthly through DPP office
- Share data with school principals and Cabinet
- Provide training (summer) on Comprehensive School Counseling Programs, Role of School Counselor, and KY Framework of Best Practices for School Counselors with School Admin Teams
- Continue monitoring each school's counseling program goal attainment
- Recommendations to District Core Team to meet the unfunded mandate of a 1:250 ratio, addressing Tier I needs post-pandemic.
- School Counselors have identified initial barriers to meeting direct service time. A review should be made of the school counselors job description and role they are currently serving.
- Recommendation for a District Wide Review of Health Curriculum and additional programs in suicide prevention, drug danger, vaping, and personal decisions

- Provide training, resources, and expectations to school administrators on Alternatives to Punitive Discipline
- Implement Alternatives to Punitive Discipline through the Code of Conduct including the removal of items excluding students from school attendance when possible.
- Creation of Threat Assessment Protocol, Procedures, and training of staff
- Continue implementation of SBTDP
- Continue Terrace Metrics Survey (3 year plan)
- Action Planning (MTSS @ NPS/NIS & PBIS @ NHS)
- Continue current mental health services and continue to seek outside providers
- Provide resources, materials, and expectations for Behavior Intervention classrooms, alternative settings, and learning strategies
- Continue Behavior Data review twice yearly
- Continue monthly/running records for behavior tier data
