AWARD OF BIDS/PROPOSALS

1. RFP 52-22 Preschool Mobile Classrooms

BACKGROUND AND RATIONALE:

The Early Childhood Department is in need of two mobile classrooms to expand services to children and families (birth to 5) in Fayette County. The mobile classrooms will visit neighborhoods and parks and provide a classroom setting for children during scheduled class times. The mobile buses will also be a resource for families with young children. The classrooms will be made using two older FCPS buses that are no longer used by Transportation and will include a generator, wifi, and HVAC, as well as seating for two adults. Proposals were solicited and reviewed based on criteria including design, cost, timeline for completion and experience with mobile early childhood classrooms.
