

FIRST ADDENDUM TO MEMORANDUM OF UNDERSTANDING

This first addendum to the Memorandum of Understanding entered into the _____ day of _____, 2022, by and between TODD COUNTY BOARD OF EDUCATION (hereinafter called "District") and the TODD COUNTY SHERIFF (hereinafter called "Sheriff");

WITNESSETH:

Whereas, the District and the Sheriff entered into a Memorandum of Understanding dated January 10, 2022; and,

Whereas, it is the desire of the Sheriff and the District to add two more Deputy Sheriffs to serve as school resource officers for the District.

NOW, THEREFORE, it should be and is hereby agreed as follows:

1. The Sheriff shall furnish to the District on the terms and conditions of the Memorandum of Understanding dated January 10, 2022, school resource officers for North Todd Elementary School and South Todd Elementary School.
2. The District shall reimburse 100% of the salary of the school resource officers for North Todd Elementary and South Todd Elementary Schools.
3. The current total annual compensation for the school resource officers for North Todd Elementary School and South Todd Elementary School shall be \$65,660.48 per school resource officer, which includes a base salary, retirement benefits, health insurance, and the employer's share of FICA. The parties recognize that all county employees will receive a 6.29% annual pay increase on January 1, 2023. The amounts hereinbefore set forth shall be adjusted at that time, consistent with the compensation increase to all county employees.

4. In each and every other respect, the Memorandum of Understanding dated January 10, 2022, remains in full force and effect and its terms are incorporated herein by rule as except as modified herein.


