HISTORY/BACKGROUND:

This is the twelfth (12th) change order for the Piner Addition and Renovation Project associated with Schrudde & Zimmerman, Inc. The original contract was \$5,719,313.59. This change order for an additional \$28,026.00 with previous change orders of \$230,630.50 makes the new contract sum \$5,977,970.09.

Item No 1: Add WAP data cabling to Existing Classrooms (17) and SRO Office (2).

Item No 2: Kitchen Hood Duct Revisions in accordance with RFIs #99 & #101, the following is a change request to cap existing roof curb; to furnish and install a new roof curb and roof same; to furnish and install support steel for the new curb; to credit the Base Bid Black Iron Welded Assemblies; to furnish and install new welded assembly, modify hood supports to clear grease duct, modify OA duct on roof to miss new exhaust fan location.
