Discussion: Fayette County Board of Education members asked questions and discussed their opinions and concerns regarding the possible property tax rate options.

Motion Passed: A motion that the Board of Education for 2022-2023 levies a total tax rate of 83.3 cents (real estate) and 83.3 cents (personal property) per \$100 assessed valuation and a total motor vehicles property rate of 59.2 cents per \$100 assessed valuation, all for the good of the common schools, in preparation of the Working Budget for School Year 2022-2023. Of this rate 5.5 cents is subject to recall. If recalled the rate automatically adjusts to the 4% rate of 78.5 cents (real estate) and 79.4 cents (personal property) passed with a motion by Ms. Christy Morris and a second by Ms. Amy Green.
