**Action/Discussion Item:**

Consider purchasing the renewal of the MAP (Measures of Academic Progress) computerized assessment program for all students in grades K-11, except for science which is grades 4 -11 at all Floyd County Schools through July 31<sup>st</sup> of the current school year. The program is a Reading, Language Arts, Mathematics, and Science online learning tool. We are currently using the program for Benchmark testing.

**Applicable Statute or Regulation:**

Board Policy 01.11 General Powers and Duties of the Board.

**Fiscal/Budgetary Impact:**

The renewed purchase of the MAP online assessment program for all students in grades K-11 except for science, which is grades 4-11 at all Floyd County Schools for the current 2022-23 school year. The program is a Reading, Language Arts, Mathematics, and Science online learning tool that will cost \$13.00 per student, which is a discount from the regular price of \$14.50. There is a \$2.50 science add-on for all students grade 4 -11. (\*Sales Order Attached) for a total cost of \$59,442.50. Title 1 funds will be used to purchase the program.

**History/Background:**

The MAP assessment program that ties MAP Growth scores (a program that we currently use as benchmark assessment) to personalized student learning pathways – complete with high-quality, Kentucky Standard-aligned exercises, instructional videos, and practice problems. Teachers can differentiate with ease, and students get support tailored to their needs, whether they are on, above or below grade level. Once students complete the initial MAP assessment this fall, MAP assigned instructional videos, practice and exercises will be based on the students resulting MAP scores. This program would help assure we were meeting the individualized needs of our students whether at home or in person.

Approve the purchase of MAP online testing program for all students in grades K-11 except for science that is grades 4-11 in all Floyd County Schools thorough July 31, 2023 of the current school year.
