Baseball	10-1-9	Umpires shall wear the navy blue pullover shirt or state association-adopted shirt.
Baseball	1-2-9	A double first base is permitted.
Baseball	1-4-4	To allow for special occasions, commemorative or memorial patches, that will be uniformly placed, not to exceed 4 square inches, to be worn on jerseys in an appropriate and dignified manner without compromising the integrity of the uniform.
Baseball	2-33-1	Suggested speed-up rules.
Baseball	4-2-2	By state association adoption, the game shall end when the visiting team is behind 10 or more runs after 4 1/2 innings, or after the fifth inning. If either team is 10 runs behind and both teams have had an equal number of times at bat.
Baseball	4-2-4	Game-ending procedures may be determined.
Baseball	4-3-1	A regulation called game where a winner cannot be determined shall be counted as a 1/2 game won and a 1/2 game lost for each team.

Gymnastics	5-1-6b note	Unless otherwise modified by state associations adoption each inquiry after the first failed inquiry that does not result in a score correction is a 0.50 deduction.
Ice Hockey	1-9-2	Only players in uniform and five other team personnel shall be permitted to occupy the team bench area, unless modified by state association adoption.

Ice Hockey	2-1-2d	By state association adoption, to allow for special occasions, comemorative or memorial patches, not to exceed 4 square inches, may be worn on jerseys with compromising the integrity of the uniform.
Ice Hockey	2-3-1	A maximum of 20 player, including goalkeepers, may dress for and play in a game, unless modified by state association adoption. It is recommended that a minimum of two goalkeepers be among the 20 players dressed.
Ice Hockey	2-3-4	By state association adoption, at the conclusion of a period, teams must remian at their bench area until the referee signals the players to proceed directly to their respective dressing rooms.
Ice Hockey	2-4-2	Teams shall be on the ice, ready to play promptly at the beginning of each period. After the first period, starting players shall remain in their half of the ice and proceed to the center ice faceoff positions. All remaining players shall proceed directly to their benches, unless modified by state asociation adoption. First violation results in a team warning. Subsequent violations shall be penalized.
Ice Hockey	2-7	Each state association may, in keeping with applicable laws, authorize exceptions to NFHS playing rules to provide reasonable accomodations to individual participants with disabilities and/or special needs, as well as those individuals with unique and extenuating circumstances. The accomodations should not fundamentally alter the sport, heighten risk to the athlete/others or place opponents at a disadvantage.
Ice Hockey	4-6-1	State associations may increase the punihment for game disqualification penalties (additional games).
Ice Hockey	9-11-1	NOTE: All games may be played under overtime policies adopted by the state high school association.
Ice Hockey	9-12-2	By state association adoption, a procedure may be establishedwhereby schools may play up to a 17-minute period.
Ice Hockey	9-12-3	By state association adoption, procedures may be established whereby games may be terminated after two period or during the third period when a team leads another team by a specidified number of goals. By state association adoption, running time may be utilized at any time when a team is leading another by a specified number of goals.
Ice Hockey	9-12-5	State Association rules may end a contest at any time due to unsatisfactory conditions.
Ice Hockey	9-13	By state association adoption, state association-authorized video replay may be used in games for reviewing goals and undetected goals, determining correct time on the clock, and to review infractions that may affect the ejection of a student-athlete. Procedures for video replay shall be determined by state association policy and procedures.

Swimming and Diving	3-1-2d	In non-championship multi-team meets, unlimited team entries are permitted unless state association policy determines otherwise. However, the individual entry rule shall be followed. (3-2-1)
Swimming and Diving	3-2-3 NOTE	May enter relay teams without the names of the competitors.
Swimming and Diving	3-3-3d	Commemorative or memorial patches may be worn on jersey for special occasions, not to exceed four square inches.
Swimming and Diving	3-3-4a	A swimmer with special needs may request suit customization from state association.
Swimming and Diving	3-3-6 NOTE	May provide accommodations to competitors with special needs or extenuating circumstances.
Swimming and Diving	3-5 NOTE	May provide additional guidance for the use of electronic devices during competition.
Swimming and Diving	4-1-7	Officials shall dress uniformly as specified by the state association.
Swimming and Diving	5-1-1 NOTE 1	Events may be modified for non-championship multi-team competition.
