HISTORY/BACKGROUND:

An advertisement to accept sealed bids for Snow Removal & Salting was posted on the district website on September 9, 2022. Bids were publicly opened on September 21, 2022 at 2:00 PM EST. This bid has three optional renewals. Due to budget constraints we are requesting to reject the proposed bid for ice melt.

FISCAL/BUDGETARY IMPACT:

Service will be provided based on weather conditions. For this reason budget estimates are unable to be determined.
