AGENDA ITEM (ACTION ITEM):

Consider/Approve the purchase of 10 School Buses for Fiscal Year 2023.

APPLICABLE BOARD POLICY:

6.1 Bus Fleet; 4.31 Authority to Encumber and Expend Funds; and 4.7 Inventories

HISTORY/BACKGROUND:

The Transportation Department is requesting to purchase eight (8) 84 passenger buses, and two (2) 66 passenger special needs buses. The increase in capacity will improve some overcrowded routes and hedge against adding routes. This strategy is important given the current labor market and shortage of bus drivers.

It is recommended to continue acquiring new buses with air conditioning, Motorola Radio Systems, Central State Camera Systems, and Paging Systems. The paging system provides an amplification system for the drivers to manage clear and concise communication with students riding in the back of the bus. The Central States Camera System allows the staff to remove a flash drive from the system to conduct an investigation with the unit still functioning as a recording device.

The cost of each 84 passenger bus is \$168,990 (does not include camera system), and the cost of each 66 passenger special needs bus is \$131,586 (includes camera system) including the additional systems as listed above.




