AGENDA ITEM (ACTION ITEM):

Consider/Approve awarding the MCT Flooring Projects RFP for Kenton Elementary, Summit View Academy and Taylor Mill Elementary to Axis Interior Systems as specified on the bid tabulation. It is also requested that \$240,000 be moved from the ESSER II Filters and Add'l ESSER Filters budgets to Add'l ESSER II – Flooring, and move \$80,000 from ESSER (ARP) Filters to ESSER (ARP) – Flooring for a total Flooring budget from ESSER II and ESSER (ARP) for flooring of \$833,635. The remaining \$5,100 required for the project would be paid for out of the 2023 Capital Outlay Fund.

HISTORY/BACKGROUND:

An advertisement to accept sealed bids for MCT Flooring Projects was posted to the district website on September 7, 2022. Bids were publicly opened September 20, 2022 at 2:00 PM EST.

FISCAL/BUDGETARY IMPACT:

Total estimated project cost of \$838,735 to be used from ESSR funds and Capital Outlay.

RECOMMENDATION:

Approval to award the MCT Flooring Projects RFP for Kenton Elementary, Summit View Academy and Taylor Mill Elementary to Axis Interior Systems as specified on the bid tabulation. It is also requested that \$240,000 be moved from the ESSER II Filters and Add'l ESSER Filters budgets to Add'l ESSER II – Flooring, and move \$80,000 from ESSER (ARP) Filters to ESSER (ARP) – Flooring for a total Flooring budget from ESSER II and ESSER (ARP) for flooring of \$833,635.
